

BLOWHOLES UPDATE

I am taking the opportunity to provide an update to the community on the progress your Shire Council is achieving in implementing the 2014 Blowholes Reserves Management Plan.

Now is a good time to put a stop to these incorrect statements and accusations on Councillors and Staff which I consider to be totally disrespectful and damaging for the Council and our community. There are some rumours being relayed throughout the community which are hard to comprehend. For example, an unsubstantiated rumour that Council has given RAC an offer for them to construct a 500 bed Caravan Park on the Blowholes Reserve. I can vehemently deny and advise the Community that this is in fact untrue and that Council has had no communication with the RAC in any regard whatsoever in relation to a caravan park.

Council continues to work closely with the Department of Planning Lands and Heritage (DPLH) on an amendment to the Plan to recognise a safe and suitable site for the proposed new Chalets that is compliant with Aboriginal Heritage, Coastal and Land planning requirements. It must also be noted that the Blowholes Protection Association (shack owners) endorsed the 2008 Master Plan which then lead to the development of the 2014 Management Plan to deliver the Master Plan

In conjunction with this, Council has issued demolition orders on the remaining twenty two squatter shacks, unfortunately the shack owners have taken Council's decision to apply the building orders to the State Appeals Tribunal (SAT). Aside from being a financial burden on your Council, this may hold up the process of implementing the plan. I must also thank those Shack owners that have removed their shacks and cleaned up the sites.



DIFFERENTIAL RATES FOR 2022/2023 TO BE SENT TO MINISTER FOR APPROVAL

As part of the 2022/2023 budget process, Council is required to endorse proposed differential rates for properties valued on an unimproved basis. The proposed differential rates presented here represent an approach to setting rates where rates are levied that reflect associated costs of providing infrastructure and services to the various ratepayers.

Differential rates have been applied to three groups of unimproved properties and range from 2.7126 cents in the dollar of valuation, to 25.9827 cents in the dollar of valuation.

The purpose of levying rates is to meet Council's budget requirements in each financial year and enables Council to raise the revenue necessary to provide facilities, infrastructure and services to the entire community and visitors of the Shire of Carnaryon.

The rates levied on properties are determined by applying the rate in the dollar to the applicable valuation amount of the properties within the district, and if applicable, applying a minimum rate. The Shire applies a minimum rate to each rating category in accordance with S6.35 of the Act, to ensure that properties with a low valuation still pay a fair and reasonable amount towards the maintenance and continuity of Shire infrastructure and services.

The method of land valuation (GRV or UV) is determined by the Minister for Local Government, Sports and Cultural Industries (the Minister) with individual valuations being provided to the Shire by the Valuer Generals Office (VGO) as part of Landgate. Valuations were revised both upwards and downwards on properties in the past weeks for Intensive Horticulture and upwards on some Mining properties.

The power to set differential rates is contained in the Local Government Act 1995 section 6.33 (1) which provides the ability to differentially rate properties, based land characteristics.

Council are seeking approval from the Minister to impose differential rates as follows -

Category	Rate of cents in the \$	Minimum Rate
UV Mining	25.9827	\$450

FEES AND CHARGES AMENDED IN THE INTERIM

Each year, as part of the budget process the Shire's Fees and Charges are adopted. However due to rapidly rising inflation and costs to the Shire of doing business, an interim amendment is necessary. This will amend the current Fees and Charges from 4pm on 30 June 2022, and be in force until the 2023 Fees and Charges Schedule is adopted with the 2022/2023 budget.

No new Fees and Charges are proposed with the amendment. New fees and charges may only be imposed if they are advertised. The 2022/2023 Budget is proposed to be adopted in the next few months. New fees and charges will be presented to Council at that time for adoption with the budget.

COUNCIL CONSIDER REQUEST TO CLOSE PUBLIC ACCESSWAY IN HAMMOND STREET

The Shire received a request from a property owner, to close the Public Access Way (PAW) adjacent to his property at Lot 3 (7) Hammond Street.

A Customer Feedback Form to the Shire on 5th January 2022 advised of anti-social behaviour occurring in the PAW that runs beside his property in Hammond Street and he has requested closure of the PAW and indicated willingness to purchase and amalgamate the PAW with his property at Lot 3 (7) Hammond Street.

If the PAW was to be closed, this would deny the opportunity for these properties to be further subdivided in the future due to a lack of access to the newly created lots. Formal closure of the PAW was therefore denied.

As a preventative measure, concrete bollards will be placed at the entry and exit.

COUNCIL APPROVES A TEMPORARY OVERFLOW CAMPING SITE AT CARDABIA STATION

In April 2022 the Shire received an application to use subject land for temporary overflow camping when no sites are available in Coral Bay, with the aim to alleviate a recurring problem in Coral Bay during peak times and to provide an opportunity for visitors to the area to experience the activities associated with an Indigenous Pastoral Station, as well as to meet the local Aboriginal residents.

Up to 60 caravans will be allowed in an area of approximately 1.4ha in size. The camping area will be on the old airstrip, which is a bare salt-flat. Existing access tracks will be used with no requirement to clear native vegetation.

The proposal is that no infrastructure be provided other than a site to park a caravan. All campers will be required to be self-contained and supplied, including waste management. A local camp host from Cardabia Station will maintain contact with overflow campers daily to ensure order and waste management are being complied with and camping fees are collected.

The additional revenue will assist the BAC to manage its commitments with the Station and make improvements to existing infrastructure.

The applicant has also applied to the Pastoral Lands Board for a diversification Permit.

The proposed use of the land is considered acceptable given the zoning of the land and the location being a cleared area with existing access. The proposed location of the overflow camping is also outside of the Coral Bay Settlement Structure Plan and, therefore, not bounded by it. However, the following matters must be addressed in the permit to ensure proper management of the camping area:

- Provision of a camp host;
- Provision of a waste dump point;
- Provision of a fire extinguisher;
- Limit the number of caravans to visit the camping site; and
- The inclusion of a general amenity condition to ensure the camping area is kept neat and tidy at all times.

HOUSE OWNER ORDERED TO DEMOLISH HOUSE GETS EXTRA TIME

The house in question was declared unfit for habitation due to significant damage. A section 137 notice under the Health (Miscellaneous Provisions) Act 1911 (the Act) was issued on 29 April 2022 ordering the house to be securely boarded up within 14 days, and taken down and removed within 60 days.

The house was boarded up as required in the notice and the owner contacted the Shire to propose repair instead of removal but requests additional time to commit to a repair date due to their current circumstances.

Section 137 of the Act provides that the local government can order such a house be removed or repaired within a timeframe and that any owner aggrieved by such a notice can apply to the State Administrative Tribunal for a review of the decision.

Section 140 of the Act provides that if the notice is not complied with within the time specified, the local government can carry out the terms of the notice and recover all expenses from the owner.

Section 371 of the Act provides that the "amount due to the local government in respect of such work may be recovered from the owner in any court of competent jurisdiction, and until paid shall be and remain a charge upon the land."

Given that the house has been securely boarded up in the timeframe nominated by the notice there is no objection to the house being repaired instead of demolished. Further, there is no objection to a temporary stay on the demolition of the house to allow the owner time to finalise refurbishment plans.

Council agreed to -

- 1.Defer enforcing demolition of the house at property #1288 as ordered under section 137 of the Health (Miscellaneous Provisions) Act 1911 until 31 December 2022 subject to the house remaining securely boarded up and the property kept in a tidy condition, and;
- 2. Require the owner to provide a refurbishment plan to the Shire by no later than 29 November 2022.\

AVIATION OPERATORS TO RECEIVE A WARNING

Council has endorsed the issuing of a formal and final warning to all Aviation Operators at Carnarvon Airport being in breach of safety compliance requirements with further breaches to result in removal of airside access for that operator and/or lease termination.

This decision has been brought about by an Aviation Operator who has, on multiple occasions, breached safety compliance requirements at the Carnarvon Airport.

Breaching safety compliance requirements and not following reasonable instructions of airport staff are therefore breaches of the existing lease conditions and place the lessee in default of that lease. Reconsideration of the offer to negotiate the new lease is also an available penalty mechanism.

Council were asked to consider the ongoing nature and extent of the airside breaches and the impact on staff resources. Staff have gone above and beyond reasonable measures as the Airport Owner to ensure compliance without success.

Requirements to always display correct airside identification and to wear hi visibility clothing is neither onerous nor unusual for airside access to airports. Targeting of the operator by airport staff is unsupported. Another Carnarvon airport operator has verbally and in writing reported the Airport Operator in question for not following the simple airside rules that are applicable to themselves. There is a documented clear pattern of noncompliance from the Airport Operator.



WALGA ADVOCACY POSITION ON ARRANGEMENTS FOR MANAGEMENT OF VOLUNTEER BUSHIRE BRIGADES

The State Government is currently drafting the Consolidated Emergency Services Act (CES Act), which consolidates the Fire Brigades Act 1942, Bush Fires Act 1954 and Fire and Emergency Services Act 1998 into a single piece of legislation, anticipated to be released as a Green Bill for consultation in early 2023.

Under the Bush Fires Act 1954, Local Governments have responsibility for bushfire and the management of volunteer Bush Fire Brigades (BFBs). 111 Local Governments manage 563 BFBs involving approximately 20,000 volunteers which was assisted by the Bushfire Board of Western Australia

DFES provides strategic leadership for emergency services across WA. DFES manages the career fire and rescue service, as well as several volunteer emergencies services such as:

- Volunteer Fire and Emergency Services (VFES);
- Volunteer Fire and Rescue Service (VFRS);
- State Emergency Services (SES); and
- Marine Rescue Western Australia.

WA is the only State in Australia in which Local Governments manage bushfire volunteers (pursuant to the Bush Fire Act 1954).

Under the Work Health and Safety Act 2020, for Volunteers and Volunteer Organisations, the Shire is responsible for all the volunteers within the Bush Fire Brigades. The Shire is required to ensure that all the Fire Control Officers (FCOs) and Bush Fire volunteers have undertaken the required training to allow them to perform the role safely.

There are very significant fines that now apply to local governments and criminal charges may be imposed on executive staff should they fail in their duty of care under the new WHS Act 2020. A significant increase in the maximum fine is now applicable to executives along with a 20-year jail term. The local government body is now subject to an uninsurable fine up to \$10M.

The proposed Advocacy position by WALGA is in line with the Shire's direction and reflects the Shire's concern in managing its Bush Fire Brigades Volunteers and the new WHS as well as the ability and the capacity for the Shire to take on the responsibility.

Council endorses the WALGA proposed Advocacy Position to the State Government in addressing this issue as part of its consolidated review of the Emergency Services Act.

COUNCIL TO HOST THE GASCOYNE GAMES 2023

The Gascoyne Games is a multi-sport games event that has occurred in the Western Australian administrative region of Gascoyne since the inaugural event held in 1994 in the Exmouth township. The organizers of the Gascoyne Games since that first event have been one of the four local governments in the region: Carnarvon, Exmouth, Shark Bay, and Upper Gascoyne.

The intention of timing for the hosting of the Games was for it to be held every second year and coordinated and organized by a different local government through a rotation process. Carnarvon previously hosted the Gascoyne Games in 2015 with Shire staff coordinating the organization of the Games with assistance from community volunteers on the organizing committee. Participating sports organizations are responsible for coordinating the competition aspects of their sport during the weekend of the Games.

The Shire of Carnarvon conducted a survey with the sporting clubs/organizations of Carnarvon to understand the best month of 2023 to hold the Gascoyne Games and to gauge an expression of interest for participating sports. We received a total of 15 expression of interest's and October 2023 was on average the chosen month.

The objective of the Gascoyne Games is to build intra-regional spirit by uniting the Gascoyne community through a weekend participation in various sporting and recreation activities. It will provide opportunities for each town in the Gascoyne region to position and market themselves in staging the games, providing development opportunities and increasing the participation of people in sport and recreation living in the Gascoyne region.

LOCAL CONTRACTOR AWARDED THE AQUATIC CENTRE MANAGEMENT CONTRACT

The Carnarvon Aquatic Centre is a community facility that not only provide an important recreational aspect The Carnarvon Aquatic Centre is a community facility providing an important venue for sport and recreational activities.

The current contract for management of the Carnarvon Aquatic Centre expires at the end of August 2022. The new season for the centre will commence in late September/October 2022.

A request for tender seeking management services for the Aquatic Centre was advertised in The West Australian and the Midwest Times on Wednesday 16 March 2022.

Acceptance of the tender submission received is a substantial increase in the management cost of the facility. To offset that increase, the tenderer is proposing the following as increase to the level of service:

- A minimum of three trained and qualified duty managers to ensure adequate supervision can always be provided accounting for contingency situations.
- An offer to review the contract price with the Shire after 12 months of operation.
- An offer to undertake a limited hours trial for an extended season in the months of May and Sept 2023. This would include a 3pm to 6pm slot 3 days a week for Lap swimmers, Aqua aerobics and Swimming club, with removal and replacement of covers before and after ensuring the water stays mostly warm.

The current Aquatic Management contract is for approximately \$200,000 per year. That price has been maintained for the past 6 years.

Based upon the recommended submission pricing, total estimated cost to manage the Aquatic Centre now is \$300,000 per year.

Council agreed to award the contract to BTX Contracting for a period of 3 years.



TEMPORARY CLOSURE OF GNARALOO-WARROORA TRACK

Gnarraloo Bay to Warroora Station

In accordance with the Local Government Act 1995 S. 3.50 and by resolution of Council, the Shire of Carnarvon advises that the coastal track from Gnarraloo Bay to the southern boundary of Warroora Station is temporarily closed for a further three months or until water levels have subsided sufficiently to allow access.

The closure is due to tidal water inundation rendering the crossing at Amherst Point 'lagoon' impassable to all vehicles. Regular inspections by Shire Officers will take place and the track reopened when the water level has subsided and the crossing is considered safe for 4WD vehicles to cross.

YEAR 4 STUDENTS LEARN ALL ABOUT LOCAL GOVERNMENT

Year 4 students from St Mary's Catholic School visited Council Chambers on Thursday 2nd June to learn all about local government and in particularly, what the Shire of Carnarvon does for the community. The students also learnt about the different services the Council provides and how decisions are made at Council Meetings.

The Chief Executive Officer, Ms Andrea Selvey, spoke to the students about the roles that the Shire President and Councillors play in local government. The students had numerous questions to ask and at the end of the session, the students were gifted a Shire 'show bag".

The students left the Chambers with a better understanding of what local government is and how the Shire of Carnarvon contributes towards the community with the provision of services and infrastructure.





REGIONAL ROADS UPDATE

- Maintenance grading was completed on Quobba-Gnaraloo Road after damage from some heavy falls.
- Grading is currently occurring at the Carnarvon airport with the plan to move to some South Roads after completion of that work.
- Bitumen resealing commenced on Sunday 12th of June. Roads included in these works are sections of Carnarvon-Mullewa Road and a number of town streets and parking bays.

2021 Flood Damage Works:

- Contractors QEM have worked on a range of Carnarvon Roads including Miaboolya Beach Road, One Tree Point Road, Bibbawarra Road, Blowholes Road shoulders and Carnarvon-Mullewa Road shoulders.
- Contractors THEM have mobilised and commenced work on the Minliya-Lyndon Road. Only minor progress has been possible to date due to the wet conditions, but we are confident given the current conditions they will now be able to make a full start. Their initial work is reconstruction and re-sheeting of approximately 5km of the road around 40km from the highway.
- Exmouth Civil mobilised equipment to Middalya to work on Minilya River Crossing reinstatement and upgrade works. Again, water in the river has delayed commencement on the ground. Exmouth Civil will be repairing undermined and cracked sections of the concrete crossing and will be installing a concrete edge wall along the upstream side of the crossing. At this stage it is hoped work will start next week as water in the river continues to drop.
- Contractor Onward Drilling has continued sinking bores in the northern region and are now towards the end of Minilya-Lyndon Road. They have had mixed results with 4 successful and 5 unsuccessful bores which were dry or with water of too little quality to benefit the project.

2022 Fires

A debrief is scheduled at the Shire Chambers for Wednesday 20th July for all affected and neighbouring properties of the Gascoyne Complex Fires at the start of the year.

The meeting will provide opportunity to discuss the situation with the Shire and DFES, as well as review plans for the upcoming summer which is already fuelled up with the rain we've been having. 
Prevention - One third of all cancers can be prevented,







CAT LAWS

In December 2011 the Cat Act was passed in Parliament and came into full effect in November 2013. The laws requires all domestic cats six months and older to be -

- Sterilised
- Microchipped
- Wearing a tag in a public place
- Registered with the local Council.

Cat owners found not to be compliant with these requirements may face fines of up to \$5,000.

Sterilisation - this will prevent unwanted kittens, reduce cat numbers in shelters and save wildlife by reducing the number of feral cats in our native bushland.

Microchipping can be done locally at the Vet and helps identify your pet if it ever gets lost or injured.

Fees for registering your cat per year (in accordance with the Cat Act) are -

Cat Registration 1 year - sterilised - \$20.00

Cat Registration 3 years - sterilised - \$42.50

Cat Registration Lifetime - sterilised - \$100.00

Cat Registration if owned by Pensioner is 50% of the above rates



THINKING OF RE-HOMING A DOG OR CAT?

All unclaimed rehomable dogs and cats that have been impounded are assessed and rehomed through SAFE Carnarvon. They are always looking for foster carers as their resources are limited. If you would like more information, please contact SAFE on 0448 569 563.

SAFE (Saving Animals From Euthanasia)

Their mission is to save companion animals from unnecessary euthanasia through community education, fostering, desexing and placing them in suitable homes.

ART GALLERY UPGRADES COMPLETED

The major Art Gallery infrastructure works which commenced in April 2022 are now complete and timed perfectly to align with the opening of our latest exhibition Wild Garden by local Gascoyne Artists Sadie James and Jess Hadden.

Carnarvon Library and Art Gallery were successful in obtaining funding through the Regional Exhibition Touring Boost (RETB) Public Regional Galleries Improvement Fund (PRGIF) which supports arts activities through improvements and upgrades for eligible galleries.



As an eligible gallery, Carnarvon Library and Art Gallery applied for funding to support an upgrade to enhance the current environmental control system within the main exhibition space. Consultant assessments identified key recommendations, the priority being to enclose the space to reduce the volume of air and subsequently improve the capacity of the current system. This is vital for exhibitions that require specific temperature and humidity control parameters and those which are sensitive to fluctuations.

Local contractors were engaged to carry out the work, enclosing the main space with an attractive wall and glass panel design. This offers continued visual access from wherever you are in the Library Lounge area.

The newly upgraded space will now be monitored with environmental data loggers over the next six months to evaluate the success of phase one of the upgrades.





RESTRICTED BURNING SEASON IS OVER

The Shire of Carnarvon's restricted burning season came to an end on the 30th April 2022. As of the 1st May 2022, you no longer need a permit to burn, however you are still required to exercise caution, manage smoke nuisance and ensure there are no plastics, chemicals, rubber, tyres or other materials that create black smoke when being burnt. Burning these materials releases toxic chemicals into the environment and can result in a penalty of up to \$5,000.

If you are unsure of what you can burn, please give Rangers a call on 99410019 and they will be happy to give you some advice.



HAZARD REDUCTION - FIRE BRIGADE ASSISTANCE

With winter coming, this is the perfect opportunity for owners to do some hazard reduction work on their properties. This can be achieved by:

- Mowing, slashing and removing long dry grass or vegetation.
- Raking or utilizing machinery to remove leaf litter and dead vegetation.
- Controlled burning is an effective way to reduce available ground fuel, however controlled burning requires considerable experience in order to be carried out safely.



If you are not comfortable in conducting a burn yourself or would like to burn a larger area on your property, the local Volunteer Fire Brigades can assist with your burns for a fee, subject to volunteer availability. Please note that this service is available on land that you own or rent only, and does not include areas adjoining your property, including road verges. All funds raised through conducting burns on private property go directly towards supporting your local volunteer fire brigades.

Engaging the brigades does not remove the landowners responsibility to adhere to the Firebreak Notice. Contact your local brigade for more information:

GO PINK brings the community together each June to make a proud pink pledge and raise funds for game-changing breast cancer research. This will help support research into effective prevention, detection and treatment of breast cancer. This much-needed research has the potential to save thousands of lives.



DID YOU KNOW?

Breast cancer is the most common cancer in women in Australia (apart from non-melanoma skin cancer) and the second most common cancer to cause death in women, after lung cancer.

Breast cancer is the abnormal growth of the cells lining the breast lobules or ducts. These cells grow uncontrollably and have the potential to spread to other parts of the body. Both men and women can develop breast cancer, although it is uncommon in men. Transwomen, non-binary people can also get breast cancer.











DO YOU NEED A JUSTICE OF THE PEACE

JPs are regularly called upon by the WA Police Force to issue search warrants. Other tasks include witnessing affidavits, statutory declarations and certifying documents. There is a need for JPs to assist at document witnessing centres and other places. JPs are expected to perform their duties consistently and be available to the public whenever possible.

When contacting JPs, please note they are volunteers who provide their services to the community free of charge. While JPs make themselves available as much as possible, it should be remembered that JPs have the same type of work and personal commitments as any other person. Accordingly, you will need to negotiate a mutually acceptable time and place for appointment.



E SCOOTERS GO SLOW AND BE AWARE OF THE RULES

Many e-scooters currently for sale in WA are illegal to use on public roads and paths in WA and can only be used on private property.

Compliant e-scooters can only be legally ridden on low speed WA public roads and paths if their maximum power output is no more than 200 watts and they cannot travel more than 10 km/h on level ground. Many e-scooters on the market are non-compliant and have motors that exceed 200 watts and can travel at speeds much faster than 10 km/h.

Riders of e-scooters that are compliant with relevant power output and speed regulations also must follow the following rules under Road Traffic Code 2000:

- Riders are permitted on footpaths and shared paths, so long as the rider keeps left and gives way to pedestrians also using the paths;
- Riders must wear a helmet:
- Riders cannot ride on roads with a speed limit exceeding 50km/h;
- Riders cannot ride on roads with a dividing line or median strip;
- Riders cannot ride on one-way roads with more than one marked lane; and
- Riders cannot ride during the hours of darkness.

Devices such as e-scooters have grown in popularity in response to community demand for more innovative and sustainable travel choices, which have the potential to lessen car dependence and more efficiently connect people to cities and communities.

With this is mind the Department of Transport is working with a range of stakeholders, including e-scooter companies, local governments and the Road Safety Commission as well as the National Transport Commission and other States and Territories, to develop a regulatory framework which could allow for the safe and convenient use of e-scooters on our transport network.

Help for uninsured house damage

There is help to clean-up damaged homes that were not insured. If you or someone you know is living with cyclone rubbish that makes the house unsafe call 1800 490 678 to find out about the help available.

Help for insured house damage

Financial help is available if your insurance claim does not cover all your repair costs. If you find yourself out of pocket due to the cost of repairing your property back to its pre-cyclone state please call 1800 490 678 for more information.

If you want to make your house stronger against future cyclones there is financial help to cover costs for installing specific upgrades in your home. To find out more go to dfes.wa.gov.au/recoveryandresiliencegrants or call 1800 490 678.

Help for small business owners

If your small business was impacted by the cyclone and you need help with the cost of

clean-up and repairs there is financial assistance available. To find out more go to smallbusiness. wa.gov.au/seroja or call 133 140.

Help for primary producers

CHECK YOUR TYRES!!





When you have come to the end of the bitumen and are heading on to dirt roads, it may be time to start thinking about your tyre pressures.

If the gravel road is smooth and well graded, and you're maintaining a similar speed to when you were driving on sealed roads, you can leave your tyre pressures as they were. But if the road surface deteriorates and you have to lower your speed to suit the conditions, you should probably think about lowering your tyre pressures. By how much will depend on the load your vehicle is carrying and the speed you're travelling at; the higher the load and the higher the speed, the more heat will be generated, so you don't want to go too low.

Lowering your tyre pressures in these conditions will not only improve your vehicle's ride quality, but also improve tyre flexibility, which can reduce the risk of chipping in the tread area.

Dropping tyres pressures for sand driving is a given, but how low will depend on several factors, including how soft the sand is, how coarse it is, whether it's wet or dry, and how hot the ambient temperature. Lowering air pressure increases the tyre's footprint, which in the case of sand helps it to float over the surface rather than dig into it.

By checking on your tyre pressures whether you are travelling on unsealed roads or sand tracks, you will ensure that you will not only arrive safely at your destination, but will protect your wheels as well as the track you are travelling on.

There is no cure or vaccine to protect against mosquito borne diseases acquired in Australia. The only way to prevent infection is to avoid being bitten. This can be done by -

- Covering up and wearing long, loose fitting, light coloured clothing, covering as much body as you can.
- When outdoors and mosquitoes are present, apply insect repellent containing DEET (diethyltoluamide) or picaridin evenly to exposed skin.
- Clean up making simple changes around your home can reduce mosquito breeding. Remove, empty or cover water-holding containers.

ABOUT THE REGIONAL AIRFARE ZONE CAP

The Regional Airfare Zone Cap is a partnership between the State Government and the airline industry. It allows WA regional residents access to capped airfares for personal travel on eligible routes to and from Perth, subject to seat availability. The State Government has committed funding of up to \$19.8 million over three years to 2025 to five airlines operating on eligible regional air routes.

ELIGIBILITY

Zone Cap fares are **only for regional residents of WA**, living outside of the Perth and Peel regions. Zone Cap fares must be booked as a return fare that departs and returns to the same regional destination.



What is e-Rates:

E-Rates is a digital copy of your rates invoice that is emailed directly to your nominated email address, replacing the traditional print version.

What are the benefits of e-Rates:

- No delays from postage.

- Digital record that you can easily access in the future.
