7.3.1 MOU - Coral Bay Boat Ramp

Cr Vandeleur – was the Shire involved in discussions with the DoT re the MOU.

Stefan Louw – yes – also asked if they would be interested in paying the Shire to monitor the land and they were not interested. The patrolling by Rangers is not a lot of effort and provides an increased presence by the Shire in the Bay.

Cr Vandeleur – do we patrol the other land not owned by the Shire

Stefan – no only that land that comes under our control, roads etc. Have approached DBCA about an MOU and they are not interested.

President – is there an expectation from the Department that patrolling will be daily.

Stefan – no, the MOU does not indicate how often that the patrolling needs to be carried out. Will trial and see how it goes and whether the patrols need to be increased.

A/CEO – there are power poles at the boat ramp and investigating whether CCTV cameras can be installed with infringements being issued through camera footage.
