#### Summary of Item:

This report details the tender process undertaken for Request for Tender RFT 09/2021 – Supply of Plant & Operators for Flood Damage Repairs (2)

It is recommended to award Contract(s) to the following Tenderers:

- 'Package 1 North' to THEM Earthmoving Pty Ltd
- 'Package 2 South' to QEM Group Australia
- 'Package 3 Central' to QEM Group Australia

#### Background:

The Shire suffered damage to various road assets from the TL12U weather event in February this year. Reinstatement cost for repair of these roads qualifies for Disaster Recovery Funding Arrangements – Western Australia (DRFA-WA) to repair damage to the pre-weather event condition.

In April 2021, Council resolved to appoint Greenfield Technical Services to assist the Shire with engineering services, Tender assistance, onsite supervision, and administrative support with DRF-WA funding.

In July/August 2021, tender RFT 04/2021 was conducted inviting suitably qualified contractors for completion of the flood damage reinstatement works. That Tender included two works packages. The first package included the northern damaged roads and the second package the southern damaged roads.

At its Ordinary Council meeting in September 2021, Council resolved as follows:

CARRIED F6/A0 After tender RFT 04/2021 award to Dean Contracting Pty Ltd, the Shire was advised Dean Contracting were unable to commit to commence works prior to end of October 2022 due to being awarded another flood damage tender.

The flood repair works were retendered introducing a third "Central" roads package and removing specific repair and upgrade works on the Middalya concrete floodway crossing. That Central package focusses on Carnarvon township roads not requiring camping facilities with an intent to attract smaller and/or local contractors. A separate tender for the Middalya crossing works was also completed and will be the subject of future reports to Council.

Tender RFT 09/2021 Supply of Plant and Operators for Road Flood Damage Repairs closed on 24 November 2021. Five submissions and one alternative submission were received. A panel evaluated all submissions. A detailed Evaluation and Recommendation report is provided in *Confidential Schedule 4.1*

#### **Financial Implications:**

Reinstatement works are funded under the DRFA-WA program. In September DFES accepted a cost estimate and funding submission for an approximate value of \$11.8 Million, including the cost of external project management. Award of the three packages will result in an estimated expenditure of \$10,219,732.

The recommended contracts will be based upon the Contractor schedule of rates and not a lump sum. Actual cost of works may vary from the expenditure estimate. Final DRFA-WA funding will adjust depending on actual hourly rates of the awarded contracts.

A small portion of the works includes *improvement* works not funded under the DRFA-WA program. It is considered cost beneficial to combine some of those works with the flood damage repair works packages, being of a similar nature.

#### Summary of Item:

This report details the process undertaken for Request for Quote (RFQ) 25/2021 – Water Bore Construction. It is recommended Council award the contract for the works to Onward Drilling.

#### Background:

The Shire suffered damage to various road assets from the TL12U flooding event in February this year. Reinstatement cost for repair of these roads qualifies for Disaster Recovery Funding Arrangements – Western

Australia (DRFA-WA) to repair damage to the pre-weather event condition. Establishment of twenty-six (26) water bores has been approved as part of the road damage repair works.

Works includes construction, drilling and establishment of twenty (20) wet bores adjacent to eleven north and south roads affected by flood damage.

An additional six (6) bores in deeper aquifers are included in the scope of works. These six bores are provisional items.

An additional provisional item has been included for replacement of three groundwater monitoring bores at the Carnarvon Browns Range Waste Facility. These works are not classified as flood repair works. Existing budgets will be utilised to pay for these works.

In October 2021, Tender, RFT 08/2021 Water Bore Construction was conducted inviting suitably qualified contractors for completion of the flood damage bore establishment works. That Tender closed on 8 of November 2021 with nil submissions received.

In accordance with S. 11.2 (C) of the Local Government (Functions and General) Regulations, public Tenders are not required if the Local Government (within the last six months) has publicly invited Tenders, but no Tender was submitted. In this case, quotations may be sought from suitable qualified suppliers. It is worth noting that an RFQ process and an RFT process is very similar, with the only difference being that the request is not advertised publicly. In all other respects, an RFQ process is as rigorous as an RFT process.

As a result of receiving no submissions for RFT 08/2021, the following eight (8) suppliers were invited to submit quotations:

A panel has evaluated and scored that submission. A detailed Evaluation and Recommendation Report is provided in *Confidential Schedule 4.2*

The recommended contract will be based upon the Contractor schedule of rates and not a lump sum. Actual cost of works may vary from the expenditure estimate. Final DRFA-WA funding will adjust depending on actual hourly rates of the awarded contracts.

Estimated cost of the Browns Range tipsite monitoring bores is \$6750. Sufficient budget to complete this work is available under the existing 21/22 adopted budget for waste facility operations.

Note that DRFWA funding will only meet the cost of wet bores – bores which find water. Dry bore costs are met by the Shire. An allocation of \$125,000 was made in the 21/22 to cover this contingency.

#### Summary of Item:

This item presents information on an application the Shire has submitted for funding from the Preparing Australian Communities Program and seeks Council's retrospective approval for the application.

#### Background:

The Australian Federal Government announced that \$600 million would be available over six years from 2021-22 to 2026-27 for the Preparing Australia Program to support projects that mitigate or reduce the disaster risk, impact and consequence associated with large-scale natural hazards.

The objectives of the Preparing Australia Program are to:

- improve the long-term resilience of Australian communities and households to natural hazards including bushfires, floods and tropical cyclones
- deliver disaster risk reduction projects that reduce hazard exposure or vulnerability and are aligned with the recommendations of the Royal Commission into National Natural Disaster Arrangements and the National Disaster Risk Reduction Framework.

The Preparing Australian Communities Program (PACP) Local stream will support disaster risk reduction and resilience initiatives that will reduce the impact of future natural hazards on Australian communities. A total of \$150 million is available from 2021-22 to 2024-25.

To be eligible, projects must fall into one of the following categories:

- Planning assessment of risk, vulnerability, resilience and disaster risk reduction activities, investment/business case, or technical feasibility
- Awareness and capacity increasing disaster risk and resilience awareness and capacity building activities
- Infrastructure delivery of built and/or natural infrastructure, including new or upgraded infrastructure.

The grant amount will be up to:

- 50% of eligible project expenditure for infrastructure projects of \$100,000 and over
- 100% of eligible project expenditure for infrastructure projects under \$100,000
- 100% of eligible project expenditure for non-infrastructure projects.

A project plan is mandatory for applications seeking a grant amount over \$1,000,000.

The Shire of Carnarvon is listed as one of 14 priority LGAs in Western Australia in relation to addressing cyclone risks and one of four in WA to addressing flood risks. This means that the Shire will be awarded an additional 20 points during the assessment process.

#### **Financial Implications:**

The projected cost of all elements of the project is \$2,200,428. The Shire of Carnarvon, together with the Department of Primary Industries and Regional Development, will be required to contribute \$809,656 in cash and kind to the project. DWER and DPIRD have confirmed the following financial commitments:

- 1. DPIRD: \$224,999
- 2. DWER: \$100,000

Should the application be accepted as presented, the Shire's **cash** co-contribution will be \$401,030 with an inkind contribution of \$83,627. The Shire will also **receive** \$127,823 in cash from the grant for project management.

No funds have been allocated for these works in the 2021/2022 budget. The Flood Mitigation Reserve contains \$11,886. To proceed as per the officer's recommendation, Council will be required to consider this funding during the 2022/2023 Budget process.

#### Comment:

DPIRD (and DWER), under the auspices of the Flood Management Working Group, have partnered with the Shire in preparing an application for funding.

The PACP Local opened for applications on 10 December 2021 and closed at 5pm AEDT on 6 January 2022. Given the timing, it was not possible to seek Council endorsement of an application prior to the closing date; however, this funding opportunity was discussed informally at the Corporate Information Session on 10 December 2021.

The infrastructure elements of this project have emerged from a formal review of the levees by GHD. After the flood event in February 2021, some issues and concerns with the levees were identified. The Department of Primary Industries and Regional Development (DPIRD) engaged GHD to conduct a formal integrity inspection of the levee system and developed a report and recommendations for remedial works.

Based on that assessment, the following works have been identified as projects that would be eligible for funding under the Preparing Australia Program.

#### Elements

#### 1. Shire of Carnarvon Town Levees.

Town Levees	Improvements Required
Carnarvon Airport Levee	Address erosion piping holes, erosion gullies and isolated sinkholes
East Carnarvon Levee	Address erosion piping holes, erosion gullies and isolated sinkholes
Morgan Town Levee	Address erosion piping holes, erosion gullies and isolated sinkholes
Robinson Street Levee	Address erosion piping holes, erosion gullies and isolated sinkholes

This element is well detailed in the GHD report which demonstrates more than sufficient evidence and rigour to substantiate the need and price estimate.

#### 2. Replace flood gates on Shire levees (five on airport levee) referenced in the GHD report.

The focus is on Airport levees "Northeast", "West" and "Morgantown". Morgantown gates can be retained with repairs; however, Airport culverts and gates require substantive work/replacement to be made sound.

#### 3. Detailed survey to define hydraulic conditions and updated Hydraulic Modelling.

The Shire has consulted with DPIRD and DWER to determine the best approach to secure this funding and, in addition to the three projects identified by the Shire (listed above) a survey and modelling of flood flows and behaviour is recommended. An understanding of the full range of expected flood events is required to support land use planning, flood emergency response planning, infrastructure design, and community flood preparedness.

Floodplain mapping and the corresponding development strategy for the Gascoyne River was last updated in 2002 and does not include the last twenty years of flood data. The December 2010 flood event is the largest flood event recorded on the Gascoyne since records began in 1959. In addition, the current flood mapping does not reflect changes that have occurred within the catchment and floodplain (e.g., road bridge upgrades, etc.) and an assessment of the impact of climate change.

More detailed surveys and incorporations of the findings into updated modelling is expected to significantly improve the comparison to the 2021 observations and increase confidence in the expected flood behaviour for larger events. Updated modelling of flood behaviour increases the ability of the local emergency managers and community to appropriate plan and respond to future flood events. (Please note: As this is "Planning" work, it will be 100% grant funded, i.e., no co-contribution is required.)

#### 4. Geotechnical Investigation.

A geotechnical investigation will be conducted to identify the properties of the material in all levees. Observation of the embankment faces treated with geo-web showed that they performed reasonably well in reducing erosion due to rainfall runoff. However, the areas where this treatment has been applied have not been subjected to a river flow and the performance under those conditions is uncertain. Rockfill protection may be required on active water faces to reduce erosion and soil loss from flood events. (Please note: As this is "Planning" work, it will be 100% grant funded, i.e., no co-contribution is required.)

#### 5. Embankment Stabilisation Review

Embankment stabilisation will be assessed to further understand contributing factors that can assist in retaining the material of the levees. This will involve investigations to confirm whether the density of small root system plants on the embankment face are providing optimal retention of soil, and whether the geo-web supporting structure and rock pitching can provide additional support in mitigating soil erosion. (Please note: As this is "Planning" work, it will be 100% grant funded, i.e., no co-contribution is required.)

#### 6. River care and floodways' management plan.

During flooding in Carnarvon horticultural area in 2021, the riverbanks, floodways and properties were significantly impacted by floodwaters. Whilst the riverbanks are in public management, the floodways are under public and private ownership. Growers located adjacent to floodway observed many of the main floodways failed to flow as intended which resulted in floodwater being diverted onto growers' properties creating damage to infrastructure and soil loss. Privately owned floodways are managed differently by each owner creating up and down stream issues for neighbours. A standard approach to management of the floodway would reduce the obstructions and impacts. (Please note: As this is "Planning" work, it will be 100% grant funded, i.e., no co-contribution is required.)

#### 7. River care and floodway's natural infrastructure upgrades.

A natural infrastructure upgrade of riverbanks and floodways in priority areas on crown land will contribute to the resilience of the community. The expected benefits include:

- a. Floodways operating as flow lines
- b. Riverbanks stabilised reducing the impact of flooding on adjoining properties
- c. Improve business resilience through the reduction in soil loss and damage to horticultural properties from flood events

As an infrastructure element, a 50 co-contribution is required. The co-contribution amount has been funded by DPRID.

#### Budget:

The projected cost of all elements of Stage 1 is \$2,200,428.

The Shire of Carnarvon, together with the Department of Primary Industries and Regional Development, has committed \$809,656 in cash and kind to the project.

Once the project is complete, the ongoing maintenance and management of the infrastructure elements will continue to be the responsibility of the Shire of Carnarvon as the asset manager.

Another potential funding source to meet the co-contribution requirement is the recently announced Federal Government grant funding program for the National Flood Mitigation Infrastructure Program. The program is managed out of the State Emergency Management Committee (at DFES). Applications for the next round 2021/22 have been sought from local (and State) government. This application is the subject of another report in the Agenda for this Special Meeting of Council – see Item 4.4.

The officer's recommendation to support this funding application is based on an taking advantage of an opportunity to secure a significant amount of funding for works, particularly in relation to the upgrades to the town levees and flood gates which otherwise would need to be fully funded by the Shire, an expense that would place consideration financial burden on the Shire. The officer also supports those elements of planning that will assist the Shire, DPIRD and DWER in better planning for flood management as these planning elements would be fully funded by the grant.

#### Summary of Item:

This item presents the details and budget implications of an application for funding under the National Flood Mitigation Infrastructure Program for Council consideration and seeks a Council's retrospective approval for the application.

#### Background:

The \$50 million National Flood Mitigation Infrastructure Program in the 2021-22 financial year aims to assist communities to prepare for future flood events. This Program was established under the Australian Government's Emergency Response Fund. It targets high priority locally and nationally significant flood mitigation infrastructure projects.

Australian State or territory governments are eligible to apply. In Western Australia the program is being managed by the Department of Fire and Emergency Services (DFES) and, on 23 December 2021, the Acting District Emergency Management Advisor, Midwest Gascoyne Operations of DFES advised that DFES was seeking expressions of interest from local governments in Western Australia. Expressions of interest are to be submitted to DFES by 14 January 2022.

The program guidelines states that "Only projects that target the construction or improvement of levee, levee systems and floodplain restoration including green infrastructure are eligible for funding."

Eligible infrastructure under the program includes:

- Levee and levee systems projects;
- Infrastructure to promote floodplain restoration; and
- Specific green infrastructure projects that mitigate flood risk.

The program will contribute to a more disaster resilient and prepared Australia by providing funding for high priority flood mitigation infrastructure to create the following outcomes:

- reducing the expected future eligible expenditure under the Disaster Recovery Funding Arrangements 2018.
- reducing the exposure to flood hazards that influence insurance affordability for relevant households or local governments, through the improvement or construction of flood mitigation infrastructure.
- mitigating against risk that influences insurance affordability for relevant household or local government by the improvement or construction of flood mitigation infrastructure.
- Reinforcement of town levees that protect homes and vital community infrastructure such as hospital, schools, airport, urban roads, retail, and government offices.
- ancillary to the above, local job creation.

The program will fund up to 75% of project costs and the remaining 25% can be met via cash and in-kind contributions from the applicant.

#### Comment:

The requirement for this work emerged from a formal review of the levees by GHD. After the flood event in February 2021, it was identified there were some issues and concerns with the levees. The Department of Primary Industries and Regional Development (DPIRD) engaged GHD to conduct a formal integrity inspection of the levee system and developed a report and recommendations for remedial works.

Based on that assessment, the following works have been identified as projects that would be eligible for funding under the National Flood Mitigation Infrastructure Program.

This element is well detailed in the GHD report which demonstrates more than sufficient evidence and rigour to substantiate the need and price estimate.

#### 9. Replace flood gates on Shire levees (five on airport levee) referenced in the GHD report. The focus is on Airport levees "Northeast", "West" and "Morgantown". Morgantown gates can be retained with repairs; however, Airport culverts and gates require substantive work/replacement to be made sound.

The officer's recommendation to support this funding application is based on an taking advantage of an opportunity to secure a significant amount of funding for works for the upgrades to the town levees and flood gates which otherwise would need to be fully funded by the Shire, an expense that would place consideration financial burden on the Shire.

#### Summary of Item:

This report details the process undertaken for Request for Tender (RFT) 12/2021 – Coral Bay Waste Facility Management Services. It is recommended Council award the contract to Coral Bay Contracting.

#### Background:

In 2011 Council awarded a contract to Coral Bay Contracting for daily management of the Coral Bay Waste Facility. This contract included collection of town litter bins including collection and disposal of fish offal bins.

That contract expired in June 2021 and has subsequently been extended until 31 January 2022. It was hoped to have a new contract finalised prior to establishment of the new Coral Bay waste facility however that has taken longer than anticipated. A Tender process has therefore been undertaken seeking a suitable contractor to continue provision of these essential waste services.

The Waste Facility caters for waste disposal of the Coral Bay community and limited surrounding areas. The Shire does not provide a kerbside bin collection service in Coral Bay. The Facility is therefore a primary drop off point for community generated waste.

The Contract includes transitioning of the waste facility to a new site. The existing waste facility is nearing capacity within the next three years. A new waste facility site located approx. 3.5 km from the town site is planned for development.

The contractor is responsible for the day-to-day operation and maintenance of the Facility. The works required include (but are not limited to) excavation of disposal pits and cells, waste placement, compacting and covering putrescible waste (incl. fish offal), control of a waste oil disposal and metal separation and recovery. The contractor is also responsible for daily pickup and cleaning of town litter bins and fish offal bins.

RFT 12/2021 – Coral Bay Waste Facility Management Services closed on 9 of December 2021. One submission, from Coral Bay Contracting, was received.

A panel has evaluated and scored the submission. A detailed Evaluation and Recommendation Report is provided in *Confidential Schedule 4.5*

#### Comment:

Receiving one submission doesn't allow comparative pricing to be assessed. Attracting contractors for work in Coral Bay is also complex due to remoteness and worker accommodation limitations.

Management of the Coral Bay Waste Facility requires a daily on-site presence for at least two to three persons. Accommodation for these workers will therefore be required. The Tender therefore required the need to provide evidence of legal workers accommodation for all personnel engaged in the conduct of the works. Coral Bay Contracting can demonstrate this evidence. It is possible the need for this evidence limited potential submissions.

The recommended contractor has provided the tendered service since 2011. Coral Bay Contracting has managed the facility and provided the bin collection service to an appropriate standard during that time. The have demonstrated clear familiarity with the site, the community, and the seasonal nature of the work. They also have established a solid working relationship with the Coral Bay Business community and to date have demonstrated a professional and effective working relationship with the Shire in the delivery of the service.
