## ARTIFICIAL REEF UPDATE

I would like to bring the community up to date regarding the Artificial Reef and the delays which have been experienced, due to no fault of the hard working Artificial Reef Committee. I am frustrated that this project has been stalled and have written the following letter to the Department involved asking for answers -

*It is quite disappointing that this project has stalled, my understanding to date is we provided the info on where the site of the proposed reef would be, a reef design was provided by Subcon. This led to us constructing the advised numbers of the three approved modules with Subcon and Recfish West's support. At this point in time we were also told that the process to gain a dumping at sea permit would commence to facilitate installation of the reef modules at a time when the Local Tug was available to place the modules.*

*Now we are faced with two of the module types cannot be installed leaving only 110 modules of the 576 constructed modules currently that can be installed. Currently Recfish West have advised they may purchase the remaining 466 modules, this is yet to be confirmed. We have missed the advised timeline for local tugs to install the modules, therefore we are faced with the costs of engaging a barge out of the Pilbara. The construction of the reef modules was completed over twelve months ago, we are now faced with another cost being paying for the storage area!*

*What should have been, could have been is just not happening through no fault of our community that worked damned hard and up to now have been patient, unfortunately it now appears its getting into the media and what should have been a positive for our Community and Recfish West is fast becoming a negative. Could you please advise when we will get genuine answers to – are we in any danger of getting the dumping at sea permit and is Recfish West going to purchase the other 466 modules please?*

Council also need to consider and resolve to appoint members to committees it wishes to retain.

The use of Council Committees to support Council functions and provide advice to Council is an important means of progressing projects and issues without the need for full Council representation.

Council representation on community and industry groups is an important link for the awareness of the Council on issues that may impact upon the community or Council business. Representation on these groups helps establish and maintain strong links with the community.

## SHIRE OF CARNARVON LOCAL LAW IN REGARD TO PUBLIC PLACES AND LOCAL GOVERNMENT PROPERTY ADOPTED BY COUNCIL

This is a significant local law which covers a wide range of issues relating to the use of property under the Shire's care, control and management. It replaces two local laws that are outdated.

The proposed local law replaces:

- Parts of the Shire of Carnarvon Local Laws Relating to Local Government Act Local Laws 1998 that deal with (amongst other things) the use of property under the Shire's care, control and management such as swimming pools, reserves, libraries, and the like; and
- The Municipality of the Shire of Carnarvon Carnarvon Airport By-laws 1993 were published in the Government gazette on 22 January 1993 and dealt with the Carnarvon airport only.

The draft local law was advertised for public comment, and a copy sent to the Minister for Local Government as required by Section 3.12(3) of the Act.

The WA Department of Local Government, Sporting and Cultural Industries (DLG) responded on behalf of the Minister and (amongst other things) suggested it may be appropriate to seek the State Governors approval to extend application of the local law outside the district boundary to allow the Shire to regulate activities on any jetties that may be under its care, control and management in future.

As such, at its meeting held on 22 June 2021 Council resolved to seek the suggested approval, which was given by way of a notice published in the Government Gazette on 26 October 2021.

Council may now 'make' the local law under Section 3.12(4) of the Act, following which it will be published in the Government Gazette .

After gazettal, local public notice will be given stating the title of the local law and summarising the purpose and effect of the local law and specifying the day on which it comes into operation. Copes will also be available or inspected at the front counter of the Shire of Carnarvon administration offices and will also be placed on Council's website.



## **HORIZON POWER GRANT COMMUNITY PARTNERSHIP FUND ACCEPTED BY COUNCIL**

The Shire of Carnarvon identified an opportunity to apply for funding through the Horizon Power Community Partnerships fund. It was identified that the community would like to activate the main street to provide a vibrant community.

The funding of \$10,000 will supplement Council's budget for the Performing Arts and Culture Program which will see a delivery of a series of community outcomes and initiatives. The program aims to deliver up to ten projects within the Carnarvon community, which includes a series of different art forms – dance which supports health and wellbeing, visual art workshops which empowers local and aboriginal artists and offers the opportunity to learn new skills, performing arts which offers theatre and music performances for the community.

## **COUNCIL MEETING TIMES TO BE REVIEWED**

Council were presented with scheduled meeting times for the upcoming 2022 Ordinary Meetings.

After some discussion, it was decided by Council that they wished to discuss further the proposed meeting times with a view to holding the meetings later in the day to accommodate members of the public who may wish to attend.

Council will consider the Ordinary Meeting commencement times at the December Council Meeting to be held on Tuesday 14 December 2021.



## **HARBOUR ROAD CONSTRUCTION TENDER AWARDED**

The project proposes to upgrade a 1.8km unsealed section of Harbour Road to a sealed standard with a minimum RAV 8 network rating.

Main Roads WA plan to install a roundabout at the intersection of Robinson and Cornish Street. Once installed, truck movements into and out of the industrial precinct via that intersection will be more restricted.

The Harbour Road project will provide the preferred route for heavy vehicles eliminating a requirement for heavy vehicles to negotiate the roundabout. It will also reduce and/or eliminate heavy vehicle movements on Robinson Street between Cornish Street and the North West Coastal Highway.

In August 2018, RFT 04/2018 Harbour Road construction project was conducted. Council resolved not to accept any submission at the time due to budget constraints. The project was deferred until adequate funding could be secured.

This has now occurred.

Greenfield Technical Services (Greenfield), acting on instruction from the Shire, prepared Tender and specification documentation. RFT 07/2021 closed on Wednesday 10 November. A Panel evaluated the submissions which resulted in a recommendation to award RFT 07/2021 to Tremor.

The award of the tender to Tremor includes the following provisional items:

- Supply and delivery of basecourse materials;
- Sprayed seal intersection treatments at the Cornish Street and Hudson St intersections.

The panel considered that the Tremor submission represented the best value for money to the Shire of Carnarvon.

Tremor are a local contractor employing a largely local workforce. This project requires utilisation of subcontract services for portions of the works not locally available. Coordination of multiple subcontractors being onsite at the required work stage is the highest risk associated with the project. The current high demand marketplace for contract services is largely beyond the ability of the Shire to reasonably mitigate.

Site works is expected to commence in the first half of 2022.

## GLADSTONE CAMP GROUND LEASE ON HOLD

Council received a request from the current lessees seeking to renew the lease for Recreational Reserve 11076 located at Lot 254 on Plan 92298 North West Coast Highway, Yaringa. The lease is located at Gladstone Bay within the Shark Bay Marine Park approximately 140 kilometres south of Carnarvon and approximately 340 kilometres North of Geraldton accessed via the Great Northern Highway.

During the initial term of the lease the Lessee was requested to create a Management Plan for the property which has not been completed however, whilst the documentation has not been formally completed it is visible that the Lessee is actively working toward completion of this document and are managing the property to high standard.

The Lessee has taken several actions for the overall improvement of the property by installing a defibrillator and assisting in the management of road closures during weather events. The camping ground has some attractive and rustic style common facilities including a communal fire pit, wood fired pizza oven, open-sided shade seated area two recently installed bush-style outdoor showers utilizing solar heated hot water, an on-site caravan for communal food preparation, toilet blocks, LPG gas refill tanks, mini golf facility, sullage dump point and camp host to assist the management of the property. The Lessee is passionate about protecting the biodiversity of the area and agreed to plant more trees to actively protect and promote the local ecosystems.

The current management of the property indicates that the Lessee is maintaining the property to a high standard and are dedicated to continuous improvement of the area and facilities to provide a niche holiday spot for travellers.

After some deliberation, Council has directed that a Management Plan for the camp area is to be presented to Council for endorsement prior to consideration being given to renewing the lease for a further 7 years. Management of the camp area will continue with the current hosts.



## GASCOYNE MEMORIAL FOUNDATION SEEK COUNCIL SUPPORT FOR SOCIAL HOUSING ECONOMIC RECOVERY PACKAGE

Council received a request from the Gascoyne Memorial Foundation Inc. (GMF) to consider assisting the GMF in their application for funding under the Social Housing Economic Recovery Package (SHERP). Specifically, the GMF is ineligible to apply and therefore requested that the Shire apply for this funding on their behalf.

The Western Australian Government recently announced a housing stimulus package with an estimated value of \$444 million to aid the state's COVID-19 economic recovery. As part of this stimulus, the Department of Communities (Communities) is leading the delivery of a \$319 million Social Housing Economic Recovery Package (SHERP). The SHERP represents a significant government investment in a pipeline of works, targeted at construction of new assets, refurbishment, and maintenance of existing assets to improve the lifespan and quality of the assets available for social housing.

The GMF has already submitted an application for workstream 3 (maintenance of their existing property on George Street) and have commenced an application for workstream 1 (new buildings). The intention is to develop vacant land the GMF owns at 7-11 George Street, Carnarvon, to increase their current capacity with a further 12 to 15 one-bedroom and two-bedroom dwellings. This development is based on their current demand for such housing.

The Department of Communities has confirmed that the Shire can apply for this funding in partnership with the GMF, and that the Shire would be required to sign the grant agreement should the application be successful. The Shire would be able to transfer the asset to the GMF once the project is completed whether they have received their registration as a housing provider or not. Therefore, any risk during the construction period would be carried by the Shire but once the asset is transfer to the GMF, they would own the asset and be responsible for the ongoing management and maintenance.

Council supported the GMF's applicaton based on that the funding would provide a significant social and economic return for Carnarvon and not applying for the funding would be an opportunity lost and applying for funding does not commit the Shire.

Notice is hereby given that the Shire of Carnarvon has prepared the above mentioned planning scheme amendment for the purpose of:

- Update Restricted Use 3 to include provisions that require structure planning and further guidance to the potential subdivision and development of Lot 308 Coral Bay;
- Modify Schedule 3 – Restricted Uses for Land in the Scheme Area – for numbers 1, 4, 5, 6, 7, 8 and 15 to allow local tourism operators to potentially cater for their employees on site by introducing Workforce Accommodation as an incidental use on tourism zoned land and as a permitted use on a private vacant tourism lot that has not yet been developed (Lot 10 Coral Bay);
- Insert a new Special Control Area 11 – Special Control Area 11: Lot 308 Coral Bay to protect existing and proposed workforce accommodation on Lot 308; and
- Modify the Scheme Maps accordingly.

## BLOWHOLES SHACKS



The Shire of Carnarvon has received a report from their qualified building surveyor, advising that the Blowholes Shacks are highly likely to collapse. During a high wind event, they will represent a dangerous structure to users. This investigation followed complaints of loose materials, including tin, blowing around the site creating a high risk to visitors.

This review has been many months in the making. Following legal advice, it has been advised that the Shacks represent a significant risk to persons within the Shire's district and, by extension, to the Shire itself.

The Shire acknowledges that the Shacks have a long and strong social heritage with locals, many of whom have spent holidays at this beautiful location over the years. However, the Shire is also ultimately responsible for the community's safety. With the upcoming cyclone season approaching for the region, the Shire needs to progress this long-running issue and safeguard future generations of holidaymakers and locals who choose to visit the Blowholes.

After the highly destructive winds experienced during Cyclone Seroja, the Shire of Carnarvon believes it is now time to proceed with the demolition of the Shacks and officers will be making that recommendation to Council in the near future.

Shire of Carnarvon CEO Andrea Selvey acknowledged that the recommendation to demolish the Shacks may arouse strong feelings among certain community members.

"Shire officers are aware that our recommendation may not be seen as a popular one, particularly among those locals who have strong ties to the Shacks historically," said Ms Selvey. "However, as has been the case in other unsafe beachside structures, such as Lancelin's Ledge Point, it remains the Shire's responsibility for the management of that land – and those who potentially are injured on that land."

The Shire's insurers advised the organisation earlier in the year that the Shire carries a significant risk concerning the Shacks. As staff and Councillors are aware that the Shacks are in a state of disrepair, are not in a safe and sound condition and have not taken all reasonable precautions to prevent personal injury, the organisation and those individual staff and Councillors are carrying the liability.

"In light of the above, the Shire has sought legal advice which states the Shacks represent a very significant risk to persons within the Shire's district, and by extension, to the Shire itself," said Ms Selvey.

"Our lawyer further advises that for the risk to be addressed, the Shire would need to take active steps to move towards requiring that the existing Shacks are demolished."

The community is encouraged to write to the Shire with any questions or concerns regarding demolishing the Blowholes Shacks. An investigation into the applicable coastal planning policies/strategies and the Aboriginal Heritage Act 1972 will all be taken into consideration by the Minister for Land to determine the site for future chalets as per the Masterplan and Management Plan.

A comprehensive FAQ is being prepared, and the Shire of Carnarvon welcomes full and frank discussions with the community regarding this issue.

### NOTICE OF ADOPTION OF LOCAL LAWS

The following Local Laws will come into effect on 24 November 2021.

#### **Bush Fire Brigades Local Law**

The purpose is to provide for the appointment or election of a captain, a first lieutenant, a second lieutenant, and such additional lieutenants as may be necessary as officers of bush fire brigades in the district and prescribe their respective duties. The effect is that the appointment or election of a captain, a first lieutenant, a second lieutenant, and such additional lieutenants as may be necessary as officers of bush fire brigades in the district is prescribed, as are their respective duties.

#### **Cemeteries Amendment Local Law**

The purpose is to amend the Shire of Carnarvon Local Laws Relating to the Carnarvon Public Cemetery 1998 to replace 'council' with 'local government' wherever it occurs, to amend provisions relating to assistance animals, and to update applicable penalties under the local law. The effect is that the Shire of Carnarvon Local Laws Relating to the Carnarvon Public Cemetery 1998 is amended.

#### **Meeting Procedures Local Law**

The purpose is to regulate the conduct of council meetings, committee meetings and electors' meetings. The effect is that meetings of council, committees and electors are to be conducted in accordance with the local law.

#### **Waste Local Law**

The purpose of the local law is to regulate the storage, collection and disposal of waste and refuse from premises and on waste facilities in the Shire. The effect is that unless otherwise authorized, the storage, collection and disposal of waste and refuse within the Shire must be carried out in accordance with the provisions of the local law.

## REGIONAL ROAD UPDATE

- Quobba Gnaraloo roadworks are on schedule and are expected to be completed in early December.
- The Shire is conducting further works in the area on behalf of DBCA including installation of a grid.
- Track markers have been placed on the Gnaraloo Warroora track.
- A public tender for the construction of up to 26 bores associated with flood damage repairs closed and unfortunately, no submissions were received. In accordance with Local Government Act regulations, the Shire may now seek quotations from suitably qualified contractors for this work.
- The Shire engaged the services of a hydrogeologist as part of the water bore aspect of the flood damage works and that consultant is nearing completion of their initial investigations.
- This bore installation is all funded under the DRFAWA program and the Shire will be able to retain these bores for future use. They are critical in improving the ability to maintain roads into the future.
- The Shire has re-advertised public tenders for the flood damage works with a revised scope. Tender RFT 09/2021 – Supply of Plant and Operators for Flood Damage Repairs II closed on 24th November and RFT 10/2021 – Middalya Crossing Concrete and Rock Protection Works closed on 1st December.
- The reissued tenders divided the project into four packages rather than the previous two. There is a northern package, a southern package, a “town” package and a package for the repair of the Middalya floodway crossing repair. The hope is that the smaller packages may be more attractive to smaller contractors.

## PRE FIRE SEASON MEETINGS - PASTORAL AREAS

The Shire will be conducting three Pre-Fire Season Meetings in the northern, eastern and southern pastoral areas with all Pastoralists encouraged to attend whichever meeting is the most convenient and details are as follows:  
(Meetings 1 and 2 were conducted prior to the publication of the newsletter.)

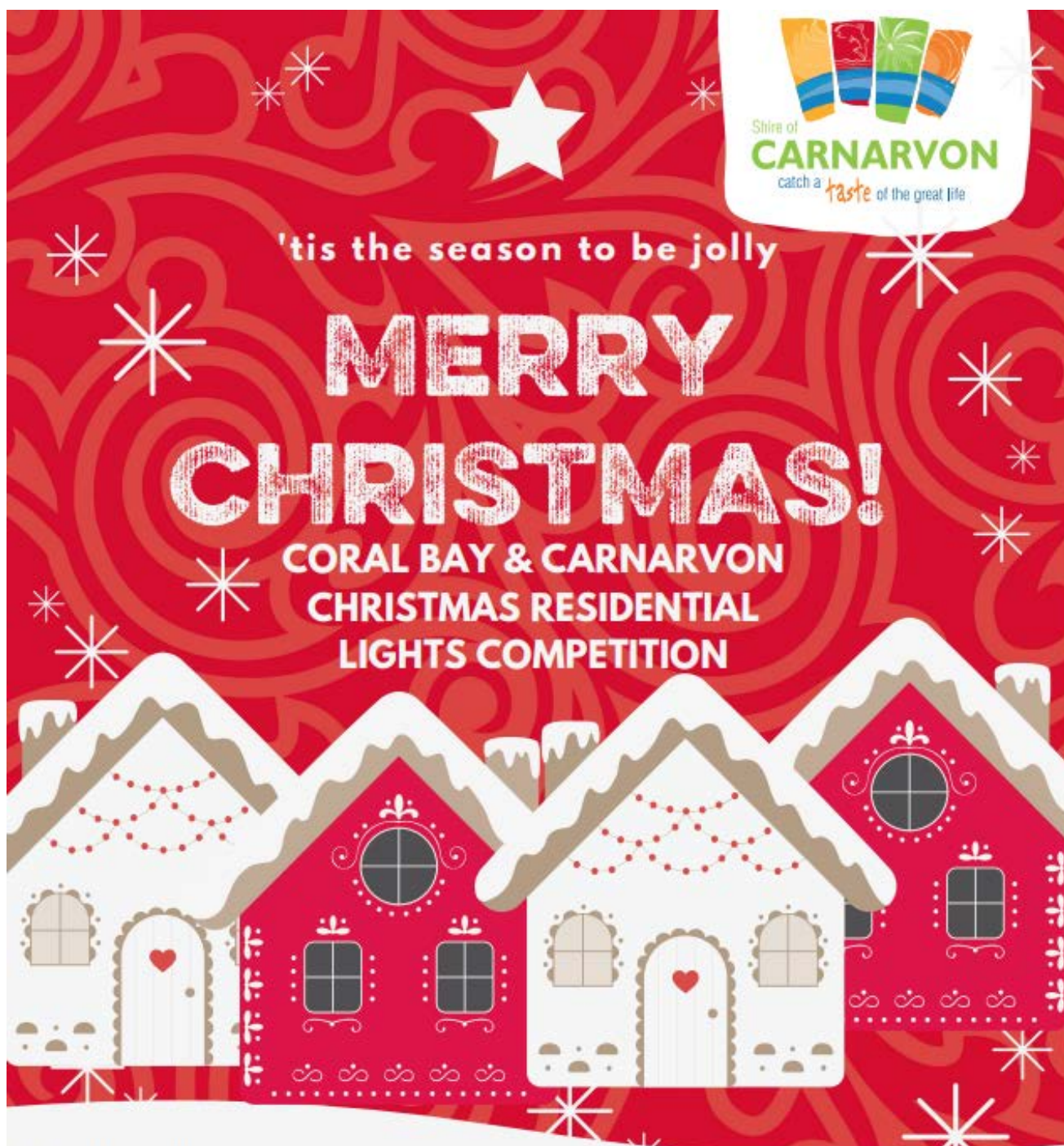

## HOW MANY DOGS CAN ONE PROPERTY HAVE?

The Shire of Carnarvon has limited the number of dogs to 2 dogs per property.

Requests for exemptions can only be approved by Council and the maximum limit you may apply for is 6 dogs per property. An application form can be obtained from the Shire office, costs \$150 and must go to Council for approval.

It is only for the dogs listed in the application and any breaches against the Dog Act or Dog Local law can result in the application being revoked. If you would like to apply to keep 3 to 6 dogs, or you have concerns with a neighbour who has a large number of dogs, please contact the Carnarvon Rangers on 0408 942 945.



## ANIMAL NEGLECT AND CRUELTY - THIS IS NOT OK!

If you have concerns for an animals welfare, the RSPCA will investigate all cruelty complaints. They need your contact details to be able to get more information if required, but be assured that any personal details you provide will remain confidential. If you believe there is an animal being abused or neglected, please contact the RSPCA who have the power to seize and care for any animal they believe is suffering, and in cases of extreme cruelty or neglect, they may prosecute the person/s responsible.

## PETS IN VEHICLES

Did you know that every year, hundreds of pets die from heat exhaustion because they are left in parked vehicles. There are many excuses as to why animals are left in cars from "Oh, it will just be a few minutes while I go into the shop" or "but I wound down the windows enough so that fresh air could get into the vehicle".

Data attained by local Australian motoring clubs shows that the ambient temperature inside a sealed car on a sunny 20-degree Celsius day can double in less than ten minutes, and rise to as much as 60 degrees C within 30 minutes. If the temperatures are hotter, then the interior temperatures rise accordingly. Even on a sunny 15-degree C day, internal temperatures can reach dangerous levels. Even night temperatures can be too much if it's a hot night. As well, studies have shown that even cracking the windows open to cool the car is essentially ineffective, as temperatures will still quickly rise to 80 per cent of the maximum potential top temp.

Please be diligent and before putting your pet in the vehicle ask yourself if you really need to take your pet with you - and if the answer is no leave your pet safely at home out of the heat.

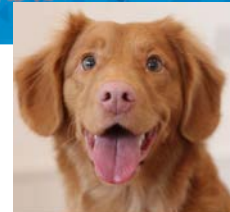

### How can I contact the Rangers?

The Rangers can be contacted during working hours of 8am to 4.30pm weekdays. The Rangers do not work weekends or after hours. The Rangers are extremely busy people, Customer Service representative will take your call, record all the details of your concern, then contact the Rangers with all the details. ### Do I have to register my Dog?

Yes. Under the Dog Act 2015, all dogs are to be registered. You can register your dog by completing the online form and making payment on the Shire of Carnarvon website or in person at 3 Francis St Carnarvon WA 6701. Alternatively, you can phone or email the shire office and request a registration form be emailed to you. You will need to supply proof of microchipping with the number, a copy of the sterilisation certificate if the dog has been sterilised.

### Does my dog have to be microchipped?

Yes. Under the Dog Act 2015, all dogs are to be microchipped. Microchips are to be inserted in accordance with the Dog Act and Regulations, by a certified person to carry out the procedure, such as a vet and registered with an approved microchip organisation. A certificate is provided at the time of microchipping as proof and with details on where to go to update your dog's information at any time. A copy of the certificate and or the microchip number is required for all dog registrations.

Question 4: How much is it to register my dog?

### I did not receive a registration renewal for my dog?

Renewals are sent to the postal address provided by the owner. It is the responsibility of the owner to ensure that the Shire has the correct postal details. If you have moved house, you will need to notify the Shire so the records can be updated to ensure you receive your renewal notice. You can update your postal information by email, phone, post or by coming into the Shire office.

### What happens to dogs in the pound?

All dogs caught by the Rangers are wormed, bathed with tick and flea shampoo, fed, watered, exercised and where necessary vet checked. The Rangers check on them, feed them and play with them twice a day, receiving excellent care and attention. The animal's welfare is most important to the Shire of Carnarvon and our Rangers.

### I have a dog in the pound. How much is it to get it out?

If your dog is in the pound, it will be \$70 impound fee, plus \$25 per day it is in there for sustenance. If the dog is not microchipped or registered there will be a \$65 fee to have the dog microchipped and Registration Fee for a minimum of 1 year which is \$50 unsterilised and \$20 for sterilised dogs.

### What happens to unclaimed dogs from the pound?

Unclaimed and surrendered dogs are fostered out until they can be rehomed by S.A.F.E

### I have a dog I don't want anymore. What do I do?

You can surrender your dog for a fee of \$70 with the Ranger. The dog will then be rehomed through S.A.F.E

If you are unsure of road conditions and want to check before you travel visit the Main Roads WA website at <https://travelmap.mainroads.wa.gov.au> and check out the Travel Map. It provides up to date road incident and impact information.



### Alerts

Incidents or issues on the road affecting access or safety. These include closures or changes due to flooding, crashes, breakdowns, bushfires and alike.



### Road closures

Information about road closures due to incidents or major planned roadworks. Road closures are shown as red lines on the map.



### Roads open to specified vehicle types

Roads may only be open to certain types of vehicles. Full closure details including the vehicles able to access the road are provided in the alert.



### Roads open with caution

Some roads may remain open however caution may be required to ensure the safety of all. For example, this includes fog incidents or minor flooding.



### Traffic signal outages

We provide the location of those traffic lights that are blocked out to help you plan a safer trip.



### Detours

Information is provided for you to safely navigate around an incident or issue on the road.



### Roadworks

Information about current or planned roadworks having the potential to cause delays to your trip.



### Events

Information about events having the potential to cause road closures or increased congestion in an area.



### Rest areas and amenities

The location and details of places to stop during your trip are provided to help ensure a safer journey. Stopping places include parking, toilets and even picnic areas.



### Google traffic

Powered by Google, this filter shows congestion across WA roads.



### Clustering

Numbers are displayed in a green cluster on the map, indicating that there are multiple alerts in that location. Simply click on the icon to see more alerts in that area.



### Alert list

A text-based list of this information is also provided. Filter by alert type, location or region and set your destination to see issues affecting your route.

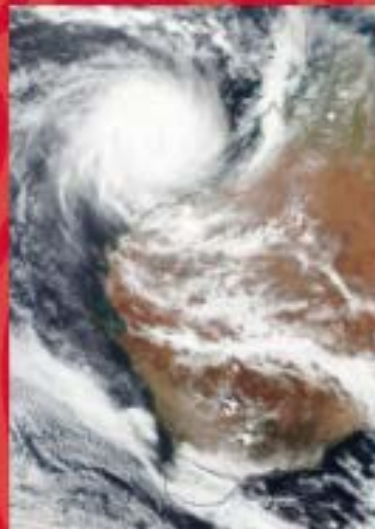

## CYCLONE – BE PREPARED!

- On average five cyclones occur off Western Australia's (WA) north-west coast each year, of these, two directly impact the coast and affect local communities. In Western Australia (WA) cyclone season starts in November and continues through to April. During this time coastal regions of WA are at risk of being impacted by cyclones.
- Preparing your family and your property for a cyclone is your responsibility, this includes being familiar with the meanings of cyclone alerts and warnings. People also need to take proper precautions and responsibility for their own welfare, prepare property inside and out and develop a cyclone plan to ensure their safety.
- Planning before the cyclone season can help save lives, minimise property damage and help your family to cope during a cyclone.
- Experiencing a cyclone can be frightening and traumatic. After a cyclone, many essential services may not be working, roads may be closed, food and water could be in short supply and your property or livelihood could be damaged.
- The strong winds produced by a cyclone (up to 280 kilometres per hour) can cause injury, loss of life, major structural damage to communities, disruption of utility and telecommunication services, and turn debris into dangerous missiles.
- Cyclone activity produces strong onshore winds and flooding rains increasing the threat of storm surge. This is a rapid rise in sea level that accompanies a cyclone as it moves ashore.
- People can drown or be fatally injured during or after a cyclone by collapsing buildings and moving debris during severe winds.
- Having an emergency kit is an important step to prepare and protect your household for unforeseen events and is essential for short term survival providing vital items for you, your family or household. It is a good idea to always keep your kit in a handy place known to everyone in the household.
- Cyclone Olwyn was the most significant cyclone to affect the Gascoyne coast in decades. Olwyn impacted Carnarvon on the 13th March 2015, causing minor to moderate damage to homes and infrastructure, significant damage to the power network, disruptions to water supply and significant damages to plantations and cropping.

## CYCLONE SEASON IS HERE!

Carnarvon is in a Cyclone area.

It is important that every household and business be in a state of readiness in case of impact. There are some simple things you can do to ensure the safety of your life and the life of others as well as your pets and home.

### **BLUE ALERT- Get ready for a cyclone**

When a blue alert is issued, you need to get ready to put your plan into place.

#### WHAT TO DO NOW:

- Keep up to date with the latest on the cyclone through radio, television and online.
- Remind everyone in the household of the cyclone plan they committed to.
- Locate your emergency kit (and if you're planning to relocate, add the additional items).
- Secure items such as boats, caravans, trailers, garden sheds, rainwater tanks, outdoor furniture, loose material and rubbish around your home and work.
- Check in with friends and neighbours to make sure they are getting prepared to.

### **YELLOW ALERT- Act now to stay safe**

If you don't take action now, the safety of you and your family are at risk.

#### WHAT TO DO NOW:

- Keep up to date with the latest on the cyclone through radio, television and online – Particularly storm surge advice.
- Put your plan in place. Go to your nearest welfare centre if you have planned to.
- Put fuel in your vehicle and park it in a sheltered area with the handbrake on and in park or first gear.
- Fasten all cyclone screens, board up or heavily tape exposed windows. Close your curtains and lock your doors.
- If you live in a low-lying area and the cyclone will create a storm surge, you may be advised to relocate now.

### **RED ALERT- Shelter now**

You need to take shelter immediately. It's too late to be getting prepared now.

#### WHAT TO DO NOW:

- Keep listening to your portable radio for information on the cyclone's progress, don't rely on your mobile phone.
- Check that your pets are safely sheltered.
- Turn off your electrical and gas supply valves.
- Go immediately to the place where you planned to shelter in your home.
- Stay inside until the ALL CLEAR is given.

### **ALL CLEAR- Be Careful**

When an ALL CLEAR is given it means the cyclone has passed, but you must be aware of hazards that may have been caused by the cyclone.

#### WHAT TO DO NOW:

- Check that your family and pets are safe and well.
- Listen to the radio and follow advice from authorities.
- Always wear shoes if you need to go outside. Be careful of fallen powerlines and trees, damaged water and sewerage lines, loose roof sheeting and other materials.
- Keep electrical appliances off until checked by a qualified tradesperson, and never use matches, cigarette lighters or naked flames as there may be a gas leak.
- If your property has sustained serious damage and you need help, call the SES on 132 500 for assistance. For life threatening emergencies, call 000.

### TEMPORARY CLOSURE - PELICAN POINT BEACH

The Shire of Carnarvon advises that a portion of Pelican Point Beach from the old Prawning Jetty to the One Mile Jetty was closed to the public from Sunday, 17 October for approximately 3 months. Partial deconstruction of the structure is required to address a significant safety risk to watercraft from detached timbers.

Closure is necessary to allow safe machinery movements along the beach. People in the area are asked to observe the safety warnings and stay away from machinery operating in the water and on the beach.

## NEW RULES TO FOR E-RIDEABLES IN WA

With the use of eRideables in WA continuing to rise, we want to make sure the State's road rules reflect the new technology and keep all Western Australians safe.

From 4 December, new laws on the use of eRideables – which include e-scooters, electric unicycles, electric skateboards, electric roller-skates, one-wheel electric scooters and hoverboards - will come into effect.

These laws will bring our State into line with other jurisdictions.

These laws for riders include:

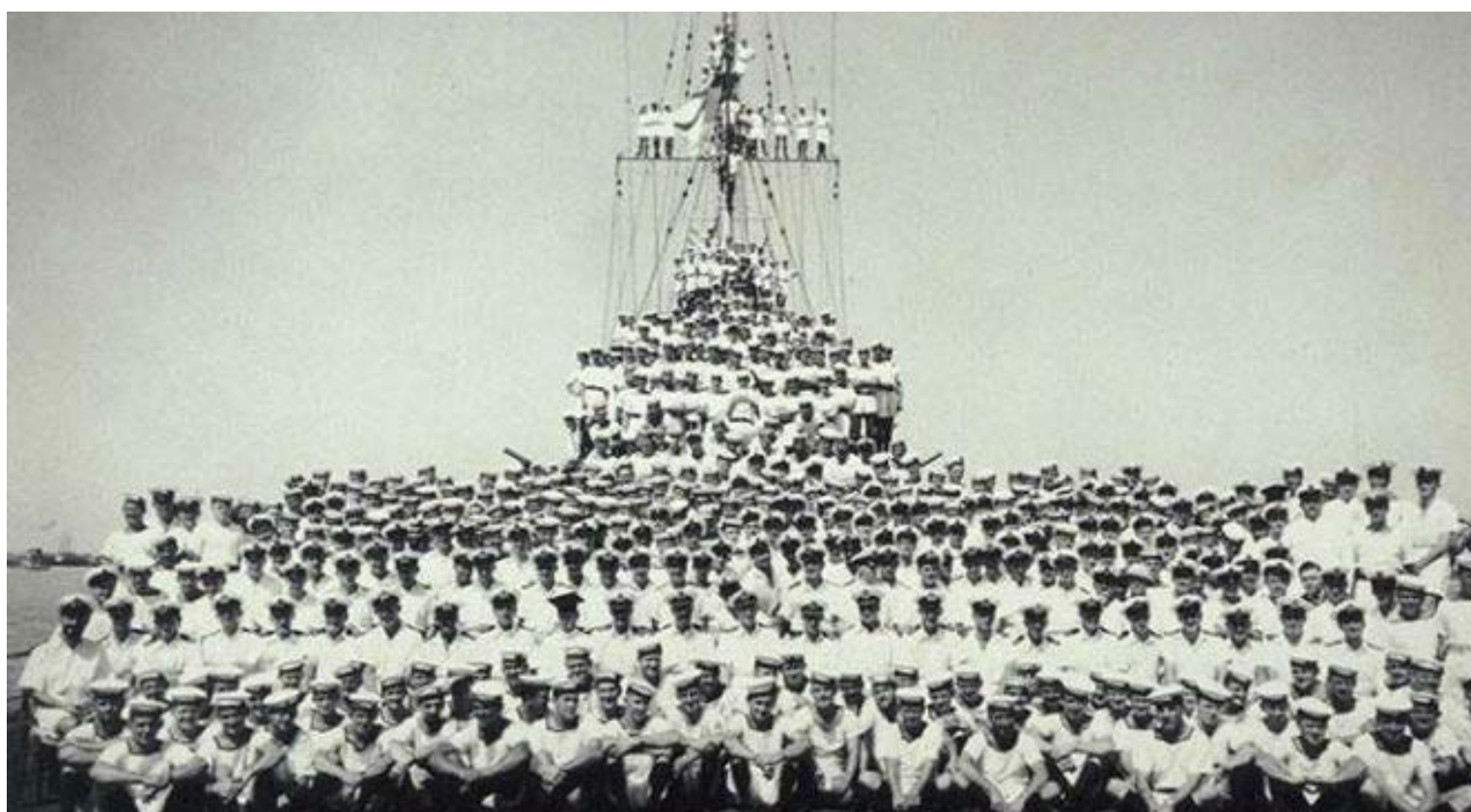
- Maximum speeds of 25km/h on bike paths and local roads, and 10km/h on footpaths and pedestrian areas
- Requirement to give way to pedestrians and keep to the left of oncoming riders
- 16 year age minimum
- Use of helmets, lights and reflectors
- The same mobile phone and drink and drug driving rules as for motor vehicle drivers

## Home Repair Grants for Seroja recovery

10 November

Local homeowners who suffered damage following Severe Tropical Cyclone Seroja can now access up to \$20,000 in Recovery and Resilience Grants to help repair their homes.

Federal Member for Durack, the Hon. Melissa Price said the grants recognise the benefits of building back better after a natural disaster.

"I have been so impressed by the efforts of so many in the impacted communities, getting on with repairs to their damaged dwellings despite some very challenging circumstances. I hope these grants will be able to assist many who are still working on the restoration of their home," Ms Price said.

There are two types of reimbursement grants available up to a total of \$20,000.

- The Recovery Grant will reimburse insured homeowners who incurred clean-up and repair costs if their insurance policy did not cover the total cost of works.
- The Resilience Grant will provide insured homeowners with the funding to undertake eligible improvements to their properties, contributing to a greater peace of mind in the advent of a future cyclone or other severe weather event.

Measures covered under the Resilience Grant include:

- Replacement of garage doors and frames with wind rated garage doors undertaken by a registered business.
- Installation of window protections including cyclone shutters or debris screens undertaken by a registered business.

Grant applications are now open for eligible insured homeowners and close 31 March 2023.

The grants program is part of the \$104 million joint Commonwealth-State Disaster Recovery Funding Arrangements package announced after the devastating impact of Cyclone Seroja in April this year.

Carnarvon's Stuart St has its newest tenant with green hydrogen developer Province Resources last month putting the finishing touches to its new office. Local tradesmen were busy painting and furnishing Province's new premises, with signage and IT services for the office also sourced locally.

It is Province's first bricks and mortar presence in town, although Carnarvon locals and company employees Tom Langley and Burke Maslen are already well known in the community. Tom is Province's Chief Operating Officer, while Burke is the Company Representative for the Gascoyne. Province is behind the HyEnergy Project, a development consisting of wind turbines and solar farms that will produce up to 8 GW of renewable energy to produce green hydrogen for domestic and international customers. While the development is still in the very early stages, the project would provide thousands of local jobs and have a significant positive impact on the local economy once in development. Province Resources is a Western Australian company with staff based in Perth and Carnarvon. Province has teamed up with Total Eren, a global leader in the development of renewable energy, for the HyEnergy Project. HyEnergy CEO David Frances said he was pleased the company now had a space in town where the community could engage with members of the Province team.

"We see the HyEnergy Project very much as Carnarvon's project," David said. "We want the community in Carnarvon and the broader Gascoyne region to feel like they are part of the team which delivered a green hydrogen project of global significance."

Green hydrogen is in demand by many countries around the world to help reduce their greenhouse gas emissions. Green hydrogen can replace fossil fuels in many applications, including heavy transport, manufacturing and mining. Electricity made from wind and solar energy is used to split water into oxygen and hydrogen, a process which produces no carbon emissions during production or when used as an energy source.

Province has a licence over the town common north of Carnarvon to investigate its potential for processing facilities and other infrastructure. Province is engaging with native title holders the Yinggarda and Baiyungu peoples on potential locations for the wind turbines and solar panels. The company is also consulting heavily with key stakeholders such as pastoralists and the Shire of Carnarvon.

About 4,000 jobs would be available during the construction phase, but that would only commence after up to three years of feasibility studies. Once operational, there would be about 1,500 permanent roles in the project, primarily locally employed.

"This project will touch many members of the Gascoyne community and we want to ensure everyone feels a part of it and understands the benefits that will flow from it," David said. "The HyEnergy Project will be providing employment and opportunities for local business for decades which is exciting for Carnarvon and the Gascoyne."

## Progressing Aboriginal Economic Development in the Gascoyne

There is a rich diversity of Aboriginal people and culture in the Gascoyne, and yet, Aboriginal peoples' economic outcomes remain lower than their non-Aboriginal counterparts. Aboriginal economic development is a core strategic priority for the Commission, and we strive to deliver transformational projects with Aboriginal people in the region.

In November 2020 the Commission hosted the second Gascoyne Aboriginal Business Development Forum, 40 Aboriginal businesses participated, and many have been inspired to continue to develop their business capacity. To build on outcomes from the Forum, the Commission has partnered with the Local Content Advisor Network (LCAN) to run a 12-month pilot program, Targeted Aboriginal Business Support (TABS), which commenced in September 2021 with eight Aboriginal businesses participating.

Businesses within this program receive intensive support through the provision of a case manager from within the Commission and LCAN, who facilitates individualised practical support from suitable agencies and industry-specific mentors. The program is overseen by a project working group of agencies that also provide generalised business support to the participating businesses.

TABS aims to work closely with businesses to build their capacity in computer literacy, digital marketing, bookkeeping and other industry-specific skills. We are excited by the enthusiasm shown so far and look forward to seeing the participating businesses flourish.

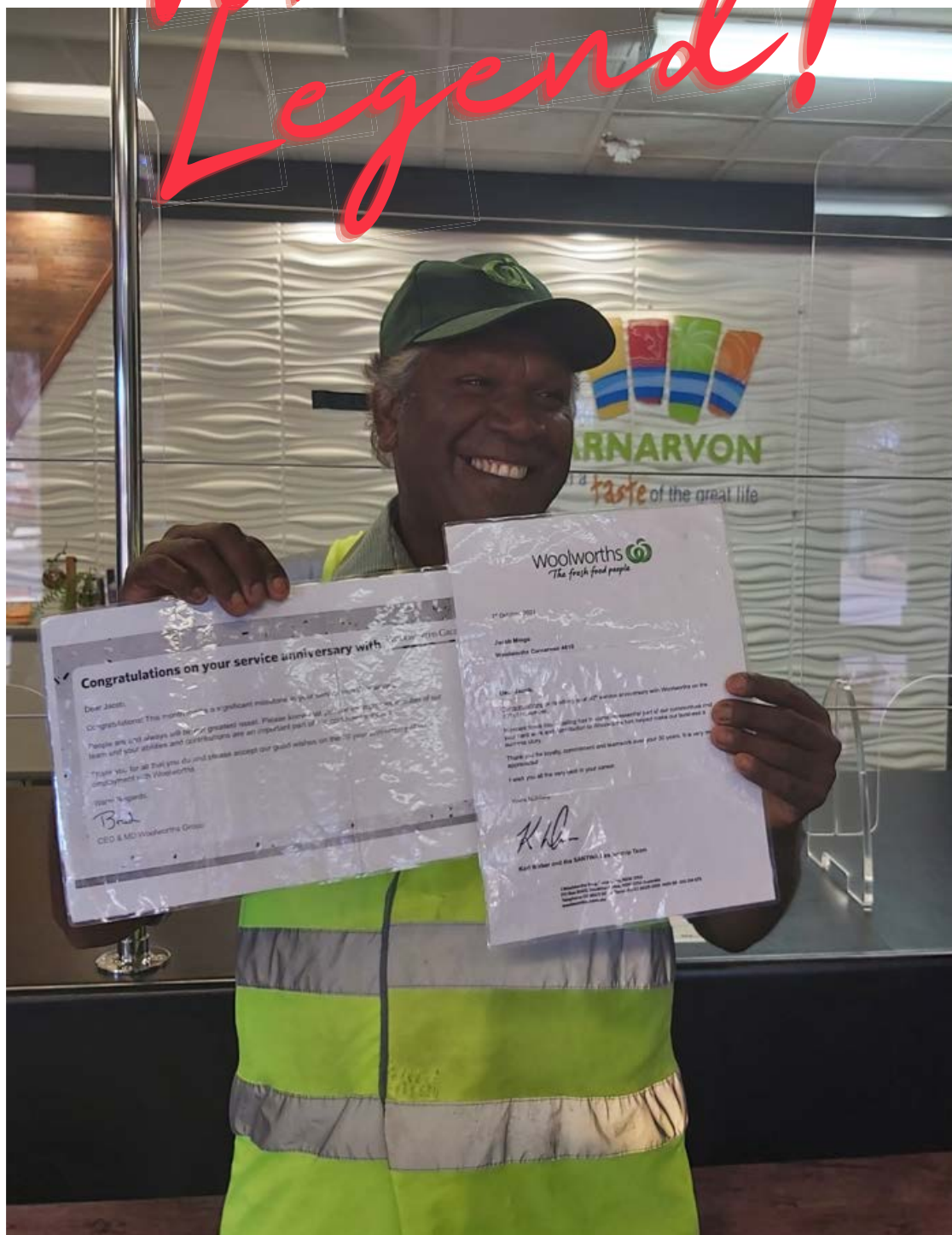

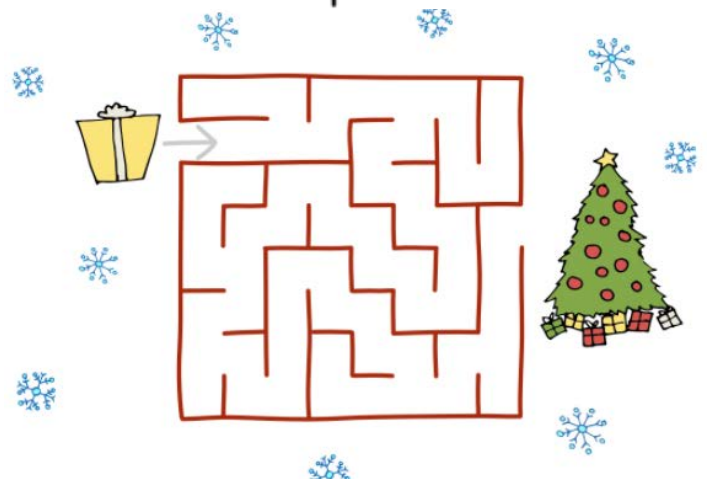
