NAIDOC History

1920s & 1930s

Before the 1920s, Aboriginal rights groups boycotted Australia Day (26 January) in protest against the status and treatment of Indigenous Australians. By the 1920s, they were increasingly aware that the broader Australian public were largely ignorant of the boycotts. If the movement were to make progress, it would need to be active.

Several organisations emerged to fill this role, particularly the Australian Aborigines Progressive Association (AAPA) in 1924 and the Australian Aborigines League (AAL) in 1932. Their efforts were largely overlooked, and due to police harassment, the AAPA abandoned their work in 1927.

In 1935, William Cooper, founder of the AAL, drafted a petition to send to King George V, asking for special Aboriginal electorates in Federal Parliament. The Australian Government believed that the petition fell outside its constitutional responsibilities.

1938

On Australia Day, 1938, protestors marched through the streets of Sydney, followed by a congress attended by over a thousand people. One of the first major civil rights gatherings in the world, it was known as the Day of Mourning.

Following the congress, a deputation led by William Cooper presented Prime Minister Joseph Lyons with a proposed national policy for Aboriginal people. This was again rejected because the Government did not hold constitutional powers in relation to Aboriginal people.

After the Day of Mourning, there was a growing feeling that it should be a regular event. In 1939 William Cooper wrote to the National Missionary Council of Australia to seek their assistance in supporting and promoting an annual event.

1940-1955

From 1940 until 1955, the Day of Mourning was held annually on the Sunday before Australia Day and was known as Aborigines Day. In 1955 Aborigines Day was shifted to the first Sunday in July after it was decided the day should become not simply a protest day but also a celebration of Aboriginal culture.

1956-1990

Major Aboriginal organisations, state and federal governments, and a number of church groups all supported the formation of NADOC, the National Aborigines Day Observance Committee. At the same time, the second Sunday in July became a day of remembrance for Aboriginal people and their heritage.

In 1972, the Department of Aboriginal Affairs was formed, as a major outcome of the 1967 referendum.

In 1974, the NADOC committee was composed entirely of Aboriginal members for the first time. The following year, it was decided that the event should cover a week, from the first to second Sunday in July.

In 1984, NADOC asked that National Aborigines Day be made a national public holiday, to help celebrate and recognise the rich cultural history that makes Australia unique. While this has not happened, other groups have echoed the call.

1991-Present

With a growing awareness of the distinct cultural histories of Aboriginal people and Torres Strait Islanders, NADOC was expanded to recognise Torres Strait Islander people. The committee became known as the National Aborigines and Islanders Day Observance Committee, NAIDOC. This new name has become the title for the whole week, not just the day. Each year, a theme is chosen to reflect the important issues and events for NAIDOC.

During the mid-1990s, the Aboriginal and Torres Strait Islander Commission (ATSIC) took over the management of NAIDOC until ATSIC was disbanded in 2004-05.

There were interim arrangements in 2005. Since then a National NAIDOC Committee, until recently chaired by former Senator Aden Ridgeway, has made key decisions on national celebrations each year. The national committee has representatives from most States and Territories.

COUNCIL PRIORITISES PROJECTS

Over the past two months, Councillors have raised legacy and emerging issues that require attention with the CEO. The Administration has also identified several activities and projects that will require resource allocation in the coming six to twelve months. Items that could not be progressed immediately or quickly, were captured on a list to ensure they were not overlooked while prioritisation and resourcing capacity is being determined. To determine which projects get priority attention, the Council and Executive team held a joint workshop to consider the items on the list in relative priority.

The workshop with Councillors provided an informal environment for the Executive and Councillors to engage in discussion about the competing priorities on human and financial resources of the organisation. The intention is for that dialogue to continue to inform resource allocation for new projects as they emerge to ensure that Shire resources are targeted in areas that are agreed priorities.

Council adopted the list of prioritised projects with the condition that they be reviewed in six months time to ensure priorities reflect any changes to the internal and external environment.

COUNCIL TO RENEW LEASE OF RUSHTON STREET TO 360 HEALTH COMMUNITY LIMITED

360 Health Community Limited (Applicant) seeking Council's approval to renew to the lease for the Health Centre located at 9-11 Rushton Street Lot 1173 and a Portion of Lot 1022.

In April 2016 Council granted a commercial lease to the Applicant for an initial term of 2 years including 3 further terms of 1 year. The final further term is due to expire on 31 July 2021. The Shire has received a request from the tenant to renew the lease for a term of 1 year and an option to extend for 1 year.

The Applicant provides health and wellbeing services to all members of the Carnarvon community. The health centre in Carnarvon is utilised by an accredited Mental Health Social worker. In order to run the programs the Applicant is depending on Government funding (State & Federal).

Local public notice will be given of Council's intention to lease the Health Centre located at Rushton Street.

GOVERNANCE REVIEW PRESENTED TO COUNCIL

On 8 January 2018, the Deputy Director General of the Department of Local Government, Sport and Cultural Industries (the Department) authorised an inquiry under section 8.3(2) of the Local Government Act 1995 involving the Shire of Carnarvon.

The nature of the Inquiry was to encompass aspects of the Shire and associated business entities that has, has had, may have, or may have had dealings with the Shire, and the operations and practices related to tendering, procurement and financial management from 1 January 2011 to the present day.

A recommendation from the Inquiry Report, was that the Shire of Carnarvon was to undertake a Governance Review which need to be made available to the Director General of the Department.

There was no public consultation in preparing this report. The consultants did consult with the Shire President, several Councillors, the CEO and key staff. The CEO also consulted with a Principal Advisory Officer at the DLGSC and his response was that the Governance Review Report appears to cover the areas identified in the scope of works endorsed by the Director General for the Governance Review and that the report is fairly comprehensive. He did note that certain findings have lost some significance due to the passing of time since the issues occurred and the persons involved. However, the report serves as an excellent opportunity to create a platform from which the Shire can positively move forward by putting in place practices and procedures to improve its operations to support good governance.

A noteworthy finding that should be recognised is that the review has found no evidence that individual Council members were not performing their roles in accordance with s.2.8, 2.9, and 2.10 of the Act and that Council is adhering to the Council Code of Conduct. These findings by two highly experienced and qualified local government practitioners, should give the community confidence that the Council is functional and compliant.

Council endorsed that Council and the Administration works together in the coming months to review all the recommendations and put a plan in place to implement the recommendations in a prioritised and systematic manner within resource capacity. The intent is that the implementation plan will be costed and presented formally to Council within three months of this meeting.

COUNCIL ENDORSES LOCAL LAWS

As part of Council's review of the local laws it is proposed to replace provisions of the Shire of Carnarvon Local Laws Relating to Local Government Act Local Laws 1998.

A local government is required to give local public notice stating that it proposes to make a local law, the purpose and effect of which is summarized in the notice for a period of 6 weeks after it first appears. A copy is also to be sent to the Minister for Local Government.

A copy of the draft local laws were sent to the Minister and local public notice duly given. Submissions closed on 25 February 2021. No comments were received from the public, but the Department of Local Government, Sporting and Cultural Industries made a number of suggestions to some of the proposed local laws.

At the Council Meeting held on 22nd June 2021 as part of the process of reviewing local laws, Council resolved to adopt the remaining following amended local laws -

- Cemeteries Amendment Local Law
- Waste Local Law
- Shire of Carnarvon Meeting Procedures Local Law
- Carnarvon Bush Fire Brigade Local Law

COUNCIL REFUSES CARNARVON YACHT CLUB'S REQUEST FOR TIP FEE WAIVER

Carnarvon Yacht Club (CYC) have formally requested a waiver of waste disposal fees at the Browns Range waste facility.

A review of operational practices at Browns Range waste facility was conducted. It identified several not-for-profit organisations disposing of waste at the facility without application of Council adopted fees and charges. This included not for profit organisations who operate at least to some extent, commercial type activities.

Clubs such as the CYC provide a valuable element to community life. Waste management and disposal is also however a part of community life and there is a cost associated with provision of that service. Fees and charges applied consistently across the community ensures users of the service contribute to its ongoing operation.

As a waste management alternative, the club can elect to pay for the collection and disposal of waste via the kerbside collection service.

COUNCIL REJECTS MOBILE TRADER'S APPLICATION IN CORAL BAY

Council has rejected an application for a mobile trading licence to trade as an Australia Post and Lotterywest agent and to provide news and gifts products and merchandise sales and services at Lot 800 (No. 79) Banksia Drive, Coral Bay. The applicant currently operates from this site as a mobile trader providing Australia Post and Lotterywest products and services. The licence is due to expire on 26 June 2021.

The applicant sought approval to use the expandable trailer van used for the Australia Post/Lotterywest licence at the northern end of Banksia Drive on Lot 800. The hours of operation sought are from 1:00pm until 5:00pm Monday to Friday. Mobile trading licences can be issued for a maximum period of 12 months.



Council refused the application on the following grounds -

1. Councillors were in agreement that the current site is not readily accessible to customers and presents a traffic hazard and danger to the public.
2. Shire of Carnarvon Local Laws Hawkers, Traders and Stall Holders, Clause 29.5 – Council may refuse to grant the licence or renewal and it may so refuse if the needs of the district of the Council or the portion thereof for which the licence is sought are adequately catered for by established shops or by persons to whom licences have been previously issued.
3. The Coral Bay Mobile Trading Policy is in contradiction to the Local Planning Scheme No. 13.

APPROVAL GRANTED TO LEASE PORTION OF NWCH FOR EXISTING TELECOMMUNICATIONS TOWER

Council received a request from ACROPP Property Consultancy – on behalf of Department of Fire Emergency Services (DFES) seeking Council's approval to lease a portion of lot 374 on Northwest Coastal highway – Reserve 38888 comprising 2,020.64M2 for the purpose of an existing telecommunication tower.

Reserve 38888 has been vested to the Shire of Carnarvon for the purpose of 'Radio Mast Site' since October 1984. The Reserve on Northwest Coastal highway is located approximately 10km south from Carnarvon Town site.



DFES has established a telecommunication tower on this site and is currently undertaking an internal review of all their telecommunications sites across WA. DFES has indicated that no formal ground lease is in place for the Carnarvon tower. In order to legalise DFES' use of the land, controlled by the Shire, a request has been made to establish a ground lease over a portion of the reserve. The total area of the reserve is over 7 hectares, DFES requested a ground lease of 2,020.64M2 in the middle of the reserve.

The vesting order of reserve 38888 – includes the power to lease of 21 years upon approval of the Minister for Lands. Before execution of the lease by both parties a request of approval by the Minister will be made by the Shire.

As the application is a government agency, it is not required to provide public notice (S. 30 Local Government (F&G) regulations 1996). If the use of site was new it may have been appropriate to provide public notice. However, given the continued used of this site for the same purpose the officer recommendation, in accordance with legislation, includes the public notice not to be required

COUNCIL ACCEPTS ADDITIONAL FUNDING FROM THE DEPARTMENT OF COMMUNITIES FOR CARNARVON COMMUNITY PATROL

The Shire has been offered a grant of \$100,000 from Department of Communities to further support the Carnarvon Community Patrol Project (CCP) for the period 1 May until 31 December 2021.

The CCP provides a non-coercive community intervention services to prevent and control anti-social and destructive behaviors. The CCP aims to maintain community peace, security, and safety within Carnarvon. It promotes culturally appropriate processes and works together with CTAG and WA Police. The project only extends to reach out to young people and vulnerable communities. At the moment the Shire is responsible for the overall operation of the CCP which includes the use of a 12-seater bus, recruitment services and administrative support. CTAC and WA Police assist the Shire in its operations during the patrols.

The Shire commenced the CCP as a pilot program in early 2021. It is the intended to increase CTAG involvement and eventually take over once the project has been fully developed. Future funding will need to be sourced to ensure the project is able to be sustained. At present the project has been funded with existing Carnarvon Youth Services funding (Department of Communities) and contributions from Council.

The additional funding (\$100,000) has been made available for the period 1 May until 31 December 2021. Accepting the additional funding will require the CCP to conduct four 'shifts' per week, instead of the current two shifts with opportunity for additional shifts during funerals, cultural and community events.

In recent years, the Council has made significant contributions to the Shire's Youth Department due to limited operational funding from external parties. At present 50% of the cost of the entire Youth Department has been funded by way of Council contributions (Year to date expenditure: \$396,177.54 and Year to date income: \$191,021.60).

Being able to secure additional funding will supplement Council's contribution for the CCP until at least 31 Dec 2021. The Shire is currently negotiating further funding, but no formal commitments have yet been made to this effect. Continuation of the funding will be dependent on the success of this pilot project.

REQUEST FOR SUBMISSIONS FOR TOWN BEACH KIOSK CONSIDERED BY COUNCIL AND AWARDED TO NINGALOO COASTAL SURFARIS FOR DEVELOPMENT OF THE FACILITY AS A CAFE AND ADVENTURE HUB

Details of an evaluation of a Request for Submissions for development of Town Beach Kiosk was submitted by Council Officers at the June 2021 Council Meeting. It was recommended that Council accepts the business case submission from Ningaloo Coastal Surfaris and that the CEO be authorised to develop and execute the necessary funding agreements and property lease to allow the proposal to be implemented.

At its August 2020 Ordinary Meeting, Council resolved to allocate \$20,000 ex GST from its Phase 1 Federal Government Local Roads and Community Infrastructure (LRCI) grant program to a Town Beach Kiosk Upgrade Project. The stated project aim is to “refurbish the kiosk at Town Beach so it can be used for a new business to be established.” To ensure monies are allocated to directly benefit establishment of a specific business, a public request for submissions was conducted. The aim of this process was to:

- a) invite submissions to establish a business at the kiosk;
- b) assess and evaluate the relative merits of those submissions and their likelihood of success; and
- c) provide a recommendation to council based on the outcome of the request for submissions process.



Prior to advertising the Request for Submission, a commercial market rental valuation for the kiosk property was sought. The weekly rental of \$95 was included in the submission documentation.

In addition to specific Kiosk improvements, under its LRCI Phase 1 approved projects Council also allocated up to \$319,000 toward Town Amenity Improvements. That is internally identified as project LRC007 and includes public toilet refurbishments in its scope of works.

The public toilet at Town Beach adjoins the kiosk facility via a covered breezeway. It has always been envisioned that a general amenity and cosmetic improvement of the entire building would be carried out regardless of the success or otherwise of the kiosk Request for Submissions process.

This refurbishment work may now be planned, costed, and implemented to coordinate with the kiosk development. This refurbishment work would include but is not limited to:

- a) corrosion removal and treatment;
- b) corroded fixing and flashing replacements;
- c) timber feature renewal and oiling;
- d) painting;
- e) landscaping;
- f) toilet fittings and fixture replacement/upgrades; and
- g) provision of additional street and park furniture.

This proposal is considered an achievable and desirable outcome for the site and meeting Council's aim to promote local business and provide additional activation of key public areas.

GDC FUNDING PUT TO GOOD USE

The Shire of Carnarvon received funding from the Gascoyne Development Commission in 2015 to develop a heritage trail. The heritage trail project has been an ongoing project which included signage and publications such as a brochure to guide visitors through the town.

The Shire Depot team has been an integral part of this project, including making the concrete pillars and installation in various locations around Carnarvon.





RUBBISH TIP FIRE

A Green Waste Tip Fire started on the afternoon of Saturday 29th May 2021. The cause of the fire is not known, however more than likely it was spontaneous combustion of broken down vegetation or a lightening strike. Volunteers from the Fire and Rescue Service and Bush Fire Service attended with Shire Staff on Saturday and established that due to the fire being deep within the green waste pile it was both unsafe and unpractical to extinguish. It was agreed that the fire would be monitored over the weekend. In consultation with the Department of Fire and Emergency service the Shire agreed to attempt to aerate the pile to promote burning during daylight hours. This continued for at least the remainder of the week and continually monitored and reviewed.

The Shire of Carnarvon managed the Fire in consultation with local volunteers and the Department of Fire and Emergency Services. Other agencies were consulted as required.

The Waste Site crews worked hard using heavy machinery to aerate the pile during the days to promote burning of the green waste material. This was an effort to minimise smoke and decrease the time the pile will take to burn out. Due to the nature of green waste and how it breaks down fires within it are hard and dangerous to extinguish. By aerating the pile this will reduce the available fuel in the safest and most efficient manner. By taking this course of action ground crews were able to access the fire sooner and more safely to extinguish it. Fire Suppression equipment was on site and standing by to be put to work as soon as it was safe to do so.

CEO AND EXECUTIVE MANAGER GO ON RURAL ROAD STATION TOURS

Both the CEO and the Executive Manager Infrastructure commenced a rural road station tour with the first trip happening on Friday 4th June and included visiting Wandagee, Middalya, Williambury and Lyndon Stations.

Unfortunately they were unable to meet with all station owners however all roads off that main route were inspected. The discussions and information sharing with the station owners was very helpful in understanding road issues and the welcome provided was warmly appreciated.

The second part of the trip was undertaken on Friday 18th June and encompassed stations to the south and south east of Carnarvon.

GRID ON BLOWHOLES ROAD REPLACED

LITTER AND THE LAW

Litter is any refuse or general waste that is discarded in an open or public place. Litter can detract from the aesthetics of an area and, depending on the nature and circumstance of the litter, can cause personal injury and/or environmental damage. Illegal dumping includes rubbish dumped at the side of a road, or items left on a verge outside of collection times.

There are many forms of littering and the Shire's Ranger Service will investigate each report. To ensure everyone continues to enjoy our shire, we've placed litter bins on streets and parks throughout the area.

Litter can include:

- Any material that is thrown or allowed to fall or is blown from a vehicle;
- the placing of waste in a reserve or public place
- the placing of domestic waste in a public rubbish bin
- the placing of bulk waste on your verge before the due date
- dumping of unwanted household, commercial or industrial waste in an open or public place
- throwing cigarette butts on the ground

Littering is an offence under the Litter Act 1979. Did you know littering carries a fine of up to \$63,000 for individuals and \$125,000 for corporations?

The Litter Act 1979 outlines what litter is and what constitutes littering. Littering offences are investigated and actioned by either the Rangers, Police officers or from the Keep Australia Beautiful Council. Illegal dumping is now covered in the Environmental Protection Act.

OFF ROAD VEHICLE USE IN SHIRE CAMPGROUNDS

As per the Control of Vehicles (Off-road Areas) Act 1978, Off Road Vehicles (ORV) are not permitted to be used within the Shire of Carnarvon unless on private property with permission from the owner, or in an ORV permitted area.

As the Shire managed campgrounds, Bush Bay, New Beach and the Blowholes, are not approved as permitted areas for ORV use, only licensed on-road vehicles can operate in these areas. If you are caught driving an ORV in one of these campgrounds, you may receive infringements and your vehicle may be seized. Driving an ORV on a gazetted road is an offence under the Road Traffic Act 1974 which may result in substantial infringements and your vehicle being seized by Police.

We ask everyone who frequents these areas to please respect our wildlife and the laws that have been put in place so everyone can enjoy our wonderful Shire. If you witness someone ignoring these laws, please report them to the Shire of Carnarvon Ranger Services – 9941 0019 – and provide photographic evidence, if available. For ORV's on the road, please contact the Carnarvon Police Ph: 9941 7333.

Permitted Off Road Vehicle Areas Permitted areas are established under the Control of Vehicles (Off-road Areas) Act 1978 and are where registered ORV's, as well as licensed on road vehicles, are allowed to be operated. Private land can only be declared as a Permitted Area with written authority of the owner.

The current publicly available, approved Permitted Areas, respective land managers and vehicles permitted in these areas are;

Gnangara, Department of Parks and Wildlife – motorcycles and quad bikes of all engine capacities.

Pinjar, Department of Parks and Wildlife – motorcycles and quad bikes (no side by sides).

Lancelin and Ledge Point - Shire of Gingin – motorcycles and quad bikes of all capacities, four wheel drives and buggies.

Kwinana, City of Kwinana – motorcycles and quad bikes of all engine capacities.

York, Shire of York – motorcycles and quads only.

Karratha, City of Karratha – all off road vehicles.

WHAT IS AN OFF-ROAD VEHICLE?

Any vehicle that is not fully road registered (Class A) under the Road Traffic (Vehicles) Act 2012 (WA) is considered an off-road vehicle. The Department of Transport describes ORV as including any vehicle that is not primarily designed for on-road activities, including;

- Trail bikes
- All-terrain vehicles (ATVs)
- Forklifts and mobile plant
- Golf carts
- Non-compliant tractors
- Non-compliant utility vehicles
- Quad bikes

SULO / WHEELIE BINS

Please remember that when you place your Sulo wheelie bin on your verge;

- the bin lid must be fully closed so wildlife are unable to pull the rubbish out and litter the street
- all rubbish must be placed inside the bin, not on the ground near the bin. This will not be removed by the Shire's rubbish removal service.

The Shire offers a weekly Mobile Garbage Bin (MGB) collection service for all residents and businesses. Please ensure that your MGBs do not weigh more than 70kgs and are placed on the verge prior to 6am on your collection day. MGBs must be in a serviceable condition (i.e. no cracks/splits that could allow rubbish to escape, not overfilled – lid to be closed etc) and orientated so that the bin lids open facing the road with handles and wheels nearest the house.

MGBs should be placed a maximum of 1m from the kerb or road edge and multiple MGB's should be spaced approximately 1m apart. For more information regarding Domestic Rubbish Collection, please contact the Shire on 9941 0000

You are responsible for this litter and can be issued an on the spot infringement of up to \$500 for individuals or up to \$2,000 for companies/business's.

You can help to reduce litter by becoming a Keep Australia Beautiful WA registered Litter Reporter and reporting offences to Keep Australia Beautiful WA.

Once you have registered you will be allocated an identification number and a kit will be forwarded to you.

Alerts

Road closures

Information about road closures due to incidents or major planned roadworks. Road closures are shown as red lines on the map.



Roads open to specified vehicle types

Roads may only be open to certain types of vehicles. Full closure details including the vehicles able to access the road are provided in the alert.



Roads open with caution

Some roads may remain open however caution may be required to ensure the safety of all. For example, this includes fog incidents or minor flooding.



Traffic signal outages

We provide the location of those traffic lights that are blacked out to help you plan a safer trip.

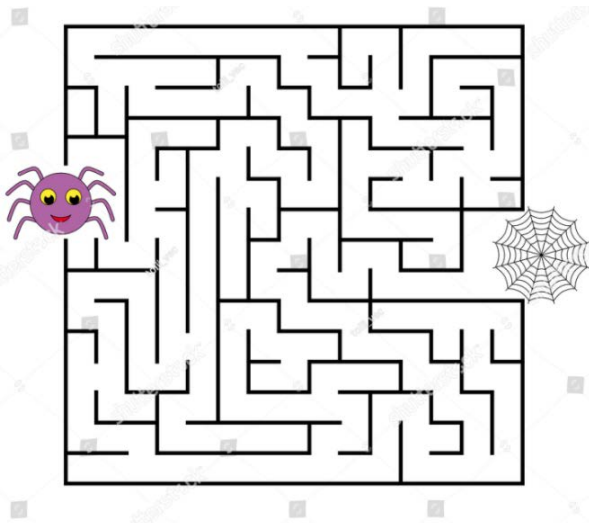
