PROVINCE RESOURCES LTD MEMORANDUM OF UNDERSTANDING EXTENDED

At the Ordinary Council Meeting in April 2021, Council resolved to enter into a Memorandum of Understanding (MoU) with Province Resources Limited (PRL) to articulate a commitment to work together in progressing PRL's aim to develop a Green Hydrogen project on a portion of the North Common, subject to all necessary and proper legislative processes.

PRL wishes to develop the HyEnergy™ Zero Carbon Hydrogen Project (the Project) in the Shire of Carnarvon.

The State has granted PRL a non-exclusive Section 91 Licence over an area of Crown land located to the north of the Carnarvon town site area.

The Licence is intended to assist PRL to assess the Project's feasibility and to help identify a suitable portion of the Licence Land that PRL would wish to lease for the Project. The Licence Land includes three Crown reserves each under a separate management order with the Shire.

PRL presently holds some preference that the Project's proposed Lease Area would be or would include a portion of the land in one or more of these three Crown reserves under the Management Orders.

Shire officers are supportive of the Project given the economic development benefit a project of this scale would bring to the Shire and the Region but understand that Council is also keen to ensure that the Shire and its residents benefit fairly from the Project.

Council agreed to extend the MOU for a further period of 12 months commencing 26 June 2024 with an option for a further 12 months extension.

AMENDMENT NO.7 TO TOWN PLANNING SCHEME NO. 13 ENDORSED TO CREATE NEW SPECIAL USE ZONE

The Shire received a request from Canford Hospitality Consultants Pty Ltd on behalf of the owners of the Minilya Bridge Roadhouse to amend the Local Planning Scheme No. 13 to create a new special use zone, which adds the 'Hotel' land use.

The amendment would allow to operators of the roadhouse to serve packaged liquor to the lodgers and travellers. As the Shire is preparing the scheme amendment in response to this application officers saw this as an opportunity to extend the scheme amendment to capture all roadhouses outside the town of Carnarvon.

The proposed amendment was presented to Council on 25 July 2023 for initiation and to publicly advertise the amendment for a period of 42 days.

Following advice received from the EPA the amendment was also advertised for 42 days in accordance with Regulation 47 of the Planning and Development (Local Planning Schemes) Regulations 2015. The amendment was advertised on the Shire's website, notices were sent to surrounding property owners and published in the Midwest Times. Only one submission was received with no objections to the proposed amendment.

Allowing the roadhouses to obtain approval as a 'Hotel', the Scheme will support further economic potential for the operators and allow them to diversify their business models. However, it is important to note that the proposed amendment does not automatically allow for the roadhouses to serve liquor; rather, it provides them the opportunity to seek development approval and subsequently liquor license approval. This is currently not a possibility under the current scheme.

Council supported the amendment based on no objections being received and the opportunity that this provides for further economic activity for local businesses and that further approvals via a Development Application and Liquor Licence Approvals, would be required should these businesses wish to progress this business activity.

PART OF RUSHTON STREET RENAMED TO DE BONI STREET IN RECOGNITION OF THE DEBONI FAMILY HISTORY IN CARNARVON

A request was received from Mr David Guglielmana advocating for a street to be named after the De Boni family in recognition of their history in establishing plantations in Carnarvon during the late 1920's.

Council considered the request at the February 2024 Council Meeting and resolved to support the proposed renaming of a section of Rushton Street to De Boni Street.

In accordance with the Council resolution, the application was forwarded to Landgate for assessment. Landgate has subsequently provided their in-principle support for the renaming.

As a result of Council's approval, public notice will now be placed via social media platforms advising of the proposed name change and the proposed renaming forwarded to the Minister for a final decision to approve or decline the renaming.



INTEGRATED WATER PLAN IN THE PIPELINE

Irrigation of Town Beach and Northwater areas will no longer be permitted by the Department of Health (DoH) under the Shire recycled water licence. It is possible to irrigate these areas with artesian water through a connection to an existing artesian pipeline adjacent to the Airport.

Advice from the Department of Health (DoH) regarding the Shire of Carnarvon Recycled Water Scheme notes an internal audit of the scheme, conducted by Water Corporation, has resulted in an overall assessment of "average" compliance with the recycled water scheme approval conditions and regulatory requirements. Of primary concern to the DoH is the use of recycled water for irrigation in the Town Beach and Northwater areas.

Auditors and the DoH have recommended recycled water irrigation cease at these two locations. The following alternative irrigation methods have been considered to allow irrigation to continue at these areas, maintaining existing green spaces. This includes irrigation by:

- Recycled water using buffers to minimise spray drift;
- Potable water;
- Non potable GWC water;
- Subsurface recycled water; and
- Artesian water.

Irrigation by artesian water is considered the most cost effective and practical long-term alternative for the ongoing irrigation of these areas. The current total recycled water irrigation area is approx. 15 ha

A quotation for design and construction of an artesian water pipeline has been received however after weighing up the advantages and disadvantages of the various sources of irrigation methods. Council were of the opinion that a detailed integrated water plan be developed prior to committing any funding towards irrigation options.

Council have resolved that the detailed Integrated Water Plan which was endorsed by Council in May 2024 as a priority project it to be completed within 12 months.

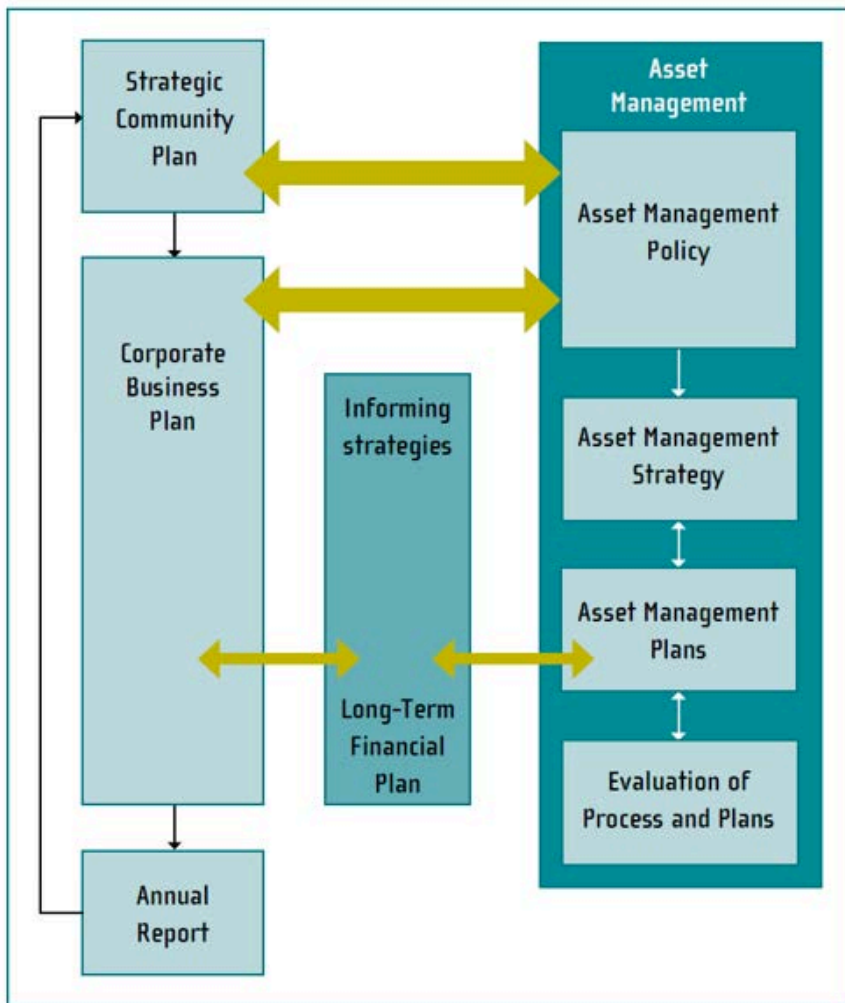
ASSET MANAGEMENT PLAN ENDORSED

As part of the integrated planning and reporting framework, local governments are required to produce a plan for the future under S5.56 (1) of the Local Government Act 1995. By regulation, that plan must include a Strategic Community Plan (SCP) and a Corporate Business Plan (CBP).

An Asset Management Plan (AMP) is what is referred to as an informing strategy within the integrated planning framework. It informs the local government of how capable it is to deliver the services and assets required by the community.

The definition of an AMP is “a tactical plan for managing infrastructure and other assets to deliver an agreed level of service.” The AMP assists decision making regarding the acquisition, renewal, and replacement of assets in accordance with the Shire Strategic Community Plan and Corporate Business Plan.

The diagram below summarises linkages between the Shire’s strategic documents within the integrated planning framework.



It should be noted within the AMP that Shire assets collectively depreciate by approximately \$9.2M each year, every year as they age and wear. That level of depreciation is unable to be fully funded given current revenues and expenditures.

The Shire is not unique to this dilemma. It is the unfortunate position many small to medium Shires find themselves in across Australia particularly where small rate bases are not supplemented by mining or other larger economic development drivers. It means Council is in a difficult position regarding maintaining existing levels of service and asset condition. That is often difficult for communities to appreciate, acknowledge and/or understand, particularly in the face of demand and need for new facilities.

This does not mean however that our current asset management practices cannot be improved to close the gap that exists between what can be afforded and what the community desires. The AMP describes measures necessary for improvement of current asset management practices. Much of that work, associated with ensuring better systems of asset inspections and early interventions, has commenced.

There are also positive indications of an increase in economic development within the Shire. The Shire’s commitment and efforts to facilitate economic development is showing results. Reversals do not however occur overnight, and the asset management journey is a lengthy process that requires long-term commitment and focus.

RECONSTRUCTION OF FLOOD GATES - QUOTATION TO BE SOUGHT

In 2023 the Shire undertook a Request for Tender (RFT) process for the repair of town levees and reconstruction of flood gates on the airport levee. Tender RFT 10/2023 was issued as two separable portions – Separable Portion A for the Repair of Town Levees and Separable Portion B for Reconstruction of Airport Levee Floodgates. RFT 10/2023 closed on 15 December 2023. One submission only was received for Separable Portion A. No submissions for Separable Portion B were received.

At the Ordinary Council Meeting held on 23 January 2024 Council resolved not to accept the submission received for Separable Portion A and authorised the CEO to seek alternative quotations for the work detailed within the scope of works for RFT 10/2023.

Based on RFT 10/2023 feedback received, a challenging element of Separable Portion B required Contractors to provide structural designs and drawings for the headwalls and floodgates that met construction standards. This required contractors to engage the services of a structural engineer to prepare floodgate structural designs and drawings. The Contractor was also required to supply and install the floodgate penstocks based on the most suitable type of gate for each identified location.

Under the funding agreement with the Department of Science, Energy and Resources, all project elements must be completed by 31 December 2024.

Council has authorised the CEO to seek alternate quotations for the project scope detailed under RFQ 05/2024 Separable Portion B - Reconstruction of Flood Gates.

Removing the flood gate reconstruction as a separable portion under the combined RFQ 05/2024 offers this element as a stand-alone item.

CONTRACT AWARDED FOR THE TECHNICAL DESIGN, SPECIFICATIONS AND CONSTRUCTION DOCUMENTATION FOR THE CARNARVON ACTIVATION PLAN PHASE ONE PROJECTS

Funding was received from Lotterywest for implementation of the first phase of the CAP. The project aims to improve the amenity and connectivity of public spaces in Carnarvon. The Shire seeks to improve and activate existing assets for use by the local community and tourists. The first Phase of the CAP project is a series of four projects at the below sites:

- Tramway walk trail – interpretive signage, furniture and fixtures, interpretive signage for healing shelter and Whitlock Island shelter;
- Town Oval - Community stage, furniture, and public art;
- Van Dongen Park - Playground and day use amenities; and
- Connect and Create - Public art installations on Robinson Street, self-standing urban screen.

In collaboration with landscape architectural consultant UDLA, a CBD revitalisation plan which included a conceptual design for the delivery of the CAP Phase 1 Project. The conceptual plan will be utilised for the delivery of the technical designs and construction documentation. These documents will form part of the construction tender.

A total project budget of \$4,961,253 has been allocated for the implementation the CAP Phase 1 Project. Most of the project budget, \$4,198,603 is externally funded by Lotterywest and LRCI. A further \$205,000 is funded by several other funding parties. The remaining \$557,650 will require a cash contribution from the Shire over two years. The contract has been award to Howard & Heaver Pty Ltd t/a H & H Architects.

COUNCIL SEEKS ASSISTANCE FROM THE MINISTER FOR LANDS TO IMPLEMENT THE BLOWHOLES RESERVE MANAGEMENT PLAN

Council at the June Council Meeting have resolved to -

1. To advise the Minister for Lands that the Shire has exhausted all options and resources in trying to implement the Blowholes Reserve Management Plan(BRMP);
2. Urgently request that the Minister for Lands provides financial, technical and practical assistance to provide a solution; and
3. Should the Minister not be able to provide that support, that the Shire will divest itself of the Blowholes Reserve as the Shire is unable to fulfill the obligations under the BRMP.

CRICKET PITCH TO BE REMOVED FROM PREMIER OVAL

The Shire of Carnarvon would like to inform you about an upcoming change at Premier Oval. The Gascoyne Football Association has requested the removal of the cricket pitch currently located on Premier Oval. This request has been made for several reasons, including ensuring the safety of football players and the possibility of hosting Western Australian Football League games in the future.

The Carnarvon Cricket Association did not oppose this removal since there is no current cricket competition. However, they have requested that the Council consider reinstating the pitch if a cricket competition is re-established in the future. We understand the importance of accommodating both sports codes.

The Council has supported this request, and the cricket pitch will be removed at the end of the 2024 football season. Additionally, the Council will explore options for reinstating the cricket pitch in the future, ensuring that both sports can utilise the ground.

CARNARVON TAKES BRONZE IN SMALL TOURISM TOWN AND CORAL BAY TAKES BRONZE IN TINY TOURISM TOWN

At the 7News Top Tourism Town Awards on 11 June, Carnarvon and Coral Bay were each awarded bronze medals in their respective categories of small and tiny tourism towns.

Towns who nominated were required to meet 37 essential criteria to secure a finalist position. Each town was assessed on several pieces of work, such as an itinerary, video submission, editorial article, and their strategic plan for growing tourism in their region. The Shire focused on producing a submission that captured the "REAL" aspects of Carnarvon and Coral Bay; something local, with local people and local experiences. We highlighted places and people in our town that resonate with what visitors are looking for when they come to Carnarvon and Coral Bay. The Shire produced the marketing campaign, editorial articles and video content in house.

"Our community will be pleased with the success of Carnarvon and Coral Bay in the tourism town awards" stated Shire President Eddie Smith, "it's fantastic to see our beautiful towns recognised".

Congratulations to Exmouth which was awarded gold in the small tourism town category and Upper Gascoyne and Shark Bay who were also finalists in this year's tiny tourism town awards. The Shire of Carnarvon is delighted see all four Shires in the Gascoyne Region excel in these awards, highlighting the Gascoyne Region as a must visit destination.



HOUSING AND WORKFORCE ACCOMMODATION SHORTAGES IN CARNARVON ADDRESSED IN URBIS 100 HOUSES REPORT

Housing and workforce accommodation shortages remain a critical constraint to Carnarvon's social and economic function. In response to this pressing issue, the Shire of Carnarvon, in partnership with the Gascoyne Development Commission, engaged consultants Urbis to conduct a comprehensive enquiry into the best options for developing the next 100 new homes in Carnarvon and to analyse the underlying causes of the housing market failure.

In August 2023, Urbis was tasked with examining various factors contributing to the housing crisis, including:

- The high cost of land and housing development
- Relatively low developed property values
- Lack of critical infrastructure, particularly reticulated sewerage
- High prevalence of older, dilapidated housing stock
- Lack of a local construction workforce

Urbis conducted extensive engagement with key stakeholders to inform the problem definition and validate background research. Stakeholders included the Department of Communities, Department of Education, Department of Planning, Lands and Heritage, Development WA, Horizon Power, and Water Corporation.

The business case provided by Urbis strongly identifies and quantifies the public benefits of housing development in Carnarvon while highlighting current market failures in meeting existing and future demand.

This report equips the Shire with the necessary data to:

- Advocate to the State government for infrastructure and policy changes that reduce barriers to housing development.
- Respond to funding opportunities with rigorously supported and competitive submissions.

The report outlines three key advocacy priorities, focusing on agencies that are instrumental in both the planning and delivery of housing in Carnarvon and their roles in addressing housing market failures. First, the Department of Communities is urged to conduct urgent repairs, maintenance, or redevelopment of vacant public housing dwellings to increase the available housing stock. Meanwhile, the Department of Planning, Lands, and Heritage is called upon to review sewerage policies to permit on-site sewage disposal for larger lots. Additionally, the Water Corporation is encouraged to investigate sewer development to unlock land for development by both the public and private sectors.

Considering the findings, the Council has received the Urbis report and will be writing to the Ministers for Education, Housing and Homelessness, Health, and Water and Environmental Regulation. The Shire will advocate for their departments to address and resolve the issues hindering housing development in Carnarvon.

Shire President Eddie Smith expressed his optimism regarding the report's findings and the future of housing development in Carnarvon "The Urbis report provides us with a clear pathway to overcome the housing and accommodation shortages that have long constrained our community. By addressing these critical issues, we can foster a more sustainable future for Carnarvon. Together, we can unlock the potential of our town and ensure that Carnarvon thrives for years to come."

The Shire of Carnarvon is committed to addressing the housing shortages and ensuring sustainable development that supports our community's social and economic well-being.





COUNCIL ENDORSES PRIORITY PROJECTS FOR 2024

The Shire of Carnarvon is pleased to announce the endorsement of its Priority Projects for 2024, marking a significant step forward in community development and infrastructure enhancement.

In 2023, the Shire developed an innovative mechanism to evaluate the 'shovel-ready' status and community benefits of various capital works projects. The assessment criteria measure the anticipated impact on community objectives—economic, social, and environmental—and the ease of implementation. This includes factors such as stakeholder engagement, funding acquisition, planning, regulatory requirements, scope of works, and budget considerations.

Projects were initially categorised into four groups based on their implementation difficulty and community impact:

- Easy to implement, low impact.
- Easy to implement, high impact.
- Difficult to implement, high impact.
- Difficult to implement, low impact.

This categorisation aims to streamline resource allocation, ensuring projects advance towards shovel-ready status and are appropriately considered in budget and task allocations. It is important to note that this assessment process does not rank projects in numerical order or dictate their delivery sequence. The progress of these projects depends on securing funding and their advancement towards shovel-ready status.

To provide further clarity, the Council has introduced additional categories to better reflect project status, importance, and progress:

- Strategic Priorities
- Shovel Ready/Partially Funded
- Concepts

Moving forward, the Council will be presented projects for endorsement bi-annually as this aligns with the Shire's budget cycle and State and Federal funding opportunities, allowing for the introduction of new projects.

Shire President Eddie Smith expressed his gratitude for the dedication and hard work of the Shire staff. "I am proud of our team for their tireless efforts in developing these priority projects. Their commitment and hard work have been instrumental in getting us to this point. These projects will greatly benefit our community as we secure funding opportunities and move towards implementation."

All projects have been thoroughly assessed against the community objectives outlined in the Shire's Strategic Community Plan, developed through community engagement to capture community objectives and priorities.

After in-depth discussion, the Council has resolved to endorse the following Priority Projects for 2024:

- Airport Relocation
- Carnarvon Trails Project
- Sports and Leisure Complex
- Fascine Waterway Basin Dredging
- Greening Carnarvon
- Integrated Plan and Water Security
- Coral Bay Workers Accommodation Caravan Park (Lot 64)

The Shire will actively pursue funding opportunities to advance these projects, using the Priority Projects Snapshot document to support funding requests and discussions with State and Federal Government representatives, agencies, and potential third-party funding bodies.



COUNCIL ADOPT MEASURED APPROACH TO 2024/2025 RATES

At the Special Council Meeting on 4 June 2024, Councillors voted unanimously to adopt a 4.5% increase in rates using a Differential Rating method to fund the 2024/2025 Annual Budget.

The purpose of levying rates is to meet the Council's budget requirements each financial year, enabling the Council to raise the necessary revenue to provide community facilities, infrastructure, and services, and to progress the aspirations and priorities identified by our community through the Strategic Community Plan.

Rates are determined by applying the rate in the dollar to the applicable valuation amount of the properties within the district. If applicable, a minimum rate is also applied. The Shire uses a minimum rate for each rating category in accordance with S6.35 of the Act, ensuring that properties with low valuations still contribute a fair and reasonable amount towards the maintenance and continuity of Shire infrastructure and services.

Over the past 12 months, rising costs have impacted households, businesses, plantations, and pastoral stations alike. The Shire has also felt the strain, working diligently to balance its budget. In the recent Council meeting, members also reviewed the proposed fencing for Pioneer Cemetery, estimated to cost approximately \$162,500.

"The Shire's costs have all gone up, from construction costs to maintenance and utilities, but so have the living costs of our ratepayers, so we want to minimise the hit if we can," said Shire President Eddie Smith, adding "Council knows that we need to have some increase to be able to fund the service expectations of our community, we hope the community is understanding of this increase."

The Notice of Intention to Impose Differential Rates is available to view on the website <https://rebrand.ly/Notice-of-Differential-Rates> as are the Objects and Reasons for Differential Rates. These are currently advertised, and feedback and submissions must be received by 4:00 pm on Thursday 4 July 2024.

SHIRE OF CARNARVON ADDRESSES BLOWHOLES SHACKS CONCERNS WITH TRANSPARENT GOVERNANCE

In a dedicated effort to uphold transparency the Shire of Carnarvon is issuing this statement to provide clarity regarding the Blowholes Shacks situation. The Shire recognises the importance of ensuring that the community is well-informed about the facts surrounding the Blowholes Shacks and the ongoing efforts to manage associated risks.

Following complaints regarding the potential for physical harm posed by the Blowholes Shacks to individuals in the area, Building Orders were promptly issued to the Shack "owners". These actions were taken after thorough consideration of advice from Shire insurers and legal counsel, emphasising the imperative of mitigating known risks to prevent exposure of the Shire and its officers.

As the holder of the Management Order for the Blowholes Reserves, the Shire is bound by clear directives from the State Government, the landowner, regarding the inconsistency of the Shacks' location with the approved Blowholes Reserves Management Plan. Consequently, the Shire was legally constrained from issuing orders for Shack repairs, necessitating the issuance of Building Orders for demolition as the most transparent and equitable course of action. The Shack owners challenged the Building Orders in the State Administrative Tribunal (SAT), and because of this challenge, the Shire has incurred legal costs of approximately \$56,000 in the last twelve months.

Despite challenges from Shack owners in the SAT, the Tribunal's decision has affirmed the safety concerns, recommending the repair or demolition of eleven Shacks by August. However, those proceedings remain ongoing and the Tribunal has not yet made any final orders, pending further submissions from the parties. Concurrently, the SAT process facilitated the repair and safety enhancement of the remaining thirteen Shacks, which largely occurred following the issue of the building orders.

Shire President, Eddie Smith, clarified, "The SAT decision solely addresses safety concerns and does not extend to the broader issue of land tenure or the status of unauthorised Shacks lacking tenure." Moving forward, Council will consider all options to try and achieve the best outcome for the entire community.

World Elder Abuse Awareness Week

OFF ROAD VEHICLES - SHIRE OF CARNARVON

As per the Control of Vehicles (Off-road Areas) Act 1978, Off Road Vehicles (ORV) are not permitted to be used within the Shire of Carnarvon unless on private property with permission from the owner, or in an ORV permitted area.

As the Shire managed campgrounds, Bush Bay, New Beach and the Blowholes, are not approved as permitted areas for ORV use, only licensed on-road vehicles can operate in these areas. If you are caught driving an ORV in one of these campgrounds, you may receive infringements and your vehicle may be seized. Driving an ORV on a gazetted road is an offence under the Road Traffic Act 1974 which may result in substantial infringements and your vehicle being seized by Police.

We ask everyone who frequents these areas to please respect our wildlife and the laws that have been put in place so everyone can enjoy our wonderful Shire. If you witness someone ignoring these laws, please report them to the Shire of Carnarvon Ranger Services – 9941 0019 – and provide photographic evidence, if available. For ORV's on the road, please contact the Carnarvon Police Ph: 9941 7333.

Permitted Off Road Vehicle Areas Permitted areas are established under the Control of Vehicles (Off-road Areas) Act 1978 and are where registered ORV's, as well as licensed on road vehicles, are allowed to be operated. Private land can only be declared as a Permitted Area with written authority of the owner.

The current publicly available, approved Permitted Areas, respective land managers and vehicles permitted in these areas are;

Gnangara, Department of Parks and Wildlife – motorcycles and quad bikes of all engine capacities.

Pinjar, Department of Parks and Wildlife – motorcycles and quad bikes (no side by sides).

Lancelin and Ledge Point - Shire of Gingin – motorcycles and quad bikes of all capacities, four wheel drives and buggies.

Kwinana, City of Kwinana – motorcycles and quad bikes of all engine capacities.

York, Shire of York – motorcycles and quads only.

Karratha, City of Karratha – all off road vehicles.

WHAT IS AN OFF-ROAD VEHICLE?

Any vehicle that is not fully road registered (Class A) under the Road Traffic (Vehicles) Act 2012 (WA) is considered an off-road vehicle. The Department of Transport describes ORV as including any vehicle that is not primarily designed for on-road activities, including;

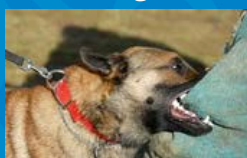
- Trail bikes
- All-terrain vehicles (ATVs)
- Forklifts and mobile plant
- Golf carts
- Non-compliant tractors
- Non-compliant utility vehicles
- Quad bikes

Use of vehicles on Pelican Point is also prohibited and if caught or photographed, you will be fined.
