Through prevention, support, and rehabilitation, this project aims to boost community well-being and public safety in Carnarvon. We're dedicated to working closely with our community and partners to create lasting, positive changes that will benefit our people now and into the future.

The Carnarvon Justice Reinvestment Group is comprised of dedicated individuals from various sectors, including grassroots community members, youth and Elders. These committed leaders are at the forefront of driving a community-led, placed-based project with a grassroots vision for improving outcomes and creating better coordinated support for their kids and families through the true empowerment of the local Aboriginal community. They meet regularly to develop and refine a strategic approach, ensuring that the needs and voices of the community are at the heart of the project.

2023/2024 ENGAGEMENT ACTIVITY

2022

- Carnarvon social issues sparked media attention
- Community wanted to come together to address social issues.
- Research into what other communities across Australia were doing to address anti-social behaviours.

2023

- Discovered the JR model and started making contacts in the JR space.
- Started initial conversations with community members and service providers – investigating how it may look for Carnarvon.
- Community members attended the Perth JR Forum in September.
- Establishment of grass roots community group they have been building and supporting the community for last 12 months.
- Started mapping services in Carnarvon.

- Initial application to PeopleWA to progress a Carnarvon specific Data collection framework to enable data-based decision making.
- JR as a standing agenda item on service provider working groups.
- Visit from Social Reinvestment WA week long workshops ending with a whole of community forum.
- Collated community feedback and distributed.
- JR Community group started working on circuit breaker initiatives that could be progressed using existing assets and required little to no funding including:
 - Carnarvon community healing project
 - Through care project for youth in Banksia
 - Youth workshop bloodbeats 15K funded by GDC
 - Establishment of a Youth group
 - On-country day trips for at-risk families and youth -50K funded by NIAA

- JR grant application with the Commonwealth was successful
- 4 community members visited Bourke, NSW, to learn from the Maranguka JR Journey.
- Hosted a whole community forum. 55 community members attended to have input on next steps, activity plan and working groups.
- 6 community members visited 2024 SRWA forum in Perth with the Carnarvon JR group presenting the Carnarvon journey to date to Forum participants from all over Australia.
- Smaller working groups established in August to progress circuit breaker initiatives - a Throughcare project for youth in detention, Family/On-Country day trips, Youth hub.
- A small working group established to design the overall structure and governance of the project to include traditional Aboriginal ways of working.
- Shire/ Department of Communities/ GDC propose changes to the Carnarvon Sub DLG Committee meetings to align with the Carnarvon JR Strategy.
- November Community surveys commenced The JR community group are using a series of surveys and small group workshops to ensure wider community have their input into the JR project.




2024 WHOLE COMMUNITY FORUM

The 2024 July Community Forum Carnarvon brought together 55 stakeholders, including community members, Aboriginal Community Controlled Organisations (ACCOs), government representatives, and NGOs.

This forum served as a vital platform to update the community on the ongoing Justice Reinvestment process in Carnarvon.


Attendees engaged in meaningful discussions about the challenges facing the community, explored potential solutions, and identified new opportunities for collaboration.
