AMENDMENT TO BOUNDARIES OF SHIRE MANAGED CROWN RESERVES - CARNARVON FLOOD MITIGATION LEVEES AGREED TO

The Shire received a request from the Department of Planning, Lands and Heritage (DPLH), to revoke its management orders affecting the flood mitigation levees (reserves). It is intended that the reserves be managed by the Water Corporation, for the purposes of 'Flood Mitigation Levee' (or similar).

On 6 July 2022 a request was received from DPLH for the revocation of the Shire's management orders over portions of Crown Reserves 19144, 46623, 31896, 37127 and 19145. The tenure amendments are required to support the tenure rationalisation required to ensure appropriate management of the Carnarvon Flood Mitigation Levees into the future.

The levees were constructed in 2011 to protect the town and horticultural district from 1-in-100-year flooding events. The levees are currently located on various Crown land parcels including a pastoral lease, Crown reserves, dedicated road reserves and unallocated Crown land. The tenure rationalisation is critical to ensuring adequate management in place for future flooding events within the Shire.

The care, control and management of reserves are governed under Section 46 of the Land Administration Act 1997 (LAA). Section 46 of the LAA allows for the Minister by order to place with any one person or jointly with more persons, the care, control and management of a reserve for the same purpose under s. 41 and for purposes ancillary or beneficial to that purpose; and may in that order subject that care, control and management to such conditions as the Minister specifies.

Council agreed to the request from the Department of Planning, Lands and Heritage to amend the boundaries of Reserves 19144, 46623, 31896, 37127 and 19145 by excising those portions that forms part of the existing levee system to be managed by the Water Corporation for the purposes of 'Flood Mitigation Levee'. The amendment of the reserves is logical, given that the Shire is not responsible for the maintenance of the levee system.



COUNCIL LAND SWAP WITH ST JOHN'S AMBULANCE

In 2017 the Ambulance Sub Centre for St John in Carnarvon moved from its old site at 5 Rushton St to a new site at 358 Robinson St, at which it had constructed a new Ambulance facility. The construction of the new Ambulance facility was funded by St John Carnarvon Sub Centre with assistance from the State of WA through Royalties for Regions and Lotterywest.

The old site is held by St John from the State as a Crown Grant in Trust (a form of tenure now known as conditional freehold) granted in the 1950s. The new site is held in freehold by the Shire of Carnarvon, but since 2013 has been leased to St John until 2033.

The proposal includes swapping the tenure at the two sites, so that the new site would be held by St John in conditional freehold from the State, and the old site would be held in freehold by the Shire of Carnarvon.

The old site includes buildings constructed by St John that could be of great use and/or value to the Shire and this proposal would enable those buildings to remain and be used for Shire, community purposes or to sell as a commercial property. In turn, St John would gain security of tenure over the new ambulance facility it has constructed at the new site.

The land swap proposal would enable the State to obtain a parcel of land of greater value than the current parcel (old site), and by the one-for-one swap would not increase the number of parcels subject to conditional freehold State-wide. The State would also thereby continue its long-standing support of the work of St John in Carnarvon by continuing to provide land from which St John can operate.

A business case was prepared for the proposal identifying opportunities, risks and benefits associated with this proposal. There are 2 options identified in the business case with option 2 being favoured by Council to acquire the property located at 5 Rushton Street.





POLICY MANUAL REVIEWED

A formal review conducted by the Department of Local Government Sport and Cultural Industries (DLGSC) recommended that the Shire of Carnarvon to undertake a Governance Review. The Shire engaged Hammond Woodhouse Advisory to conduct an independent governance review in May 2021. The following is an extract of findings and recommendations from the Hammond Woodhouse report dated 2 June 2021 that relate to Council Policies.

Following the review, Council and senior staff attended a policy workshop to review the changes to ensure compliance with legislation and ensure they meet the requirements of the Shire of Carnarvon. This has resulted in this updated policy manual to inform decision making and provide clear guidelines for Council and employees.

In approving the Policy Manual, there were 2 policies that were excluded including -

- Policy No. ID003 (Grid Policy) –which requires further consultation with station owners; and
- Policy No. ID002 (Maintenance of Shire Roads, Station Access Roads and Station Airstrips) which requires further amendment in regard to the listing of the regional roads;

which will be re-presented to Council to consider at the September Council Meeting.

CARNARVON RACECOURSE ROAD UPDATE

At the Council Meeting, Cr Fullarton sought an update on the status regarding the progress towards the sealing of the Racecourse Road to the Carnarvon Golf Club.

It was advised that officers have sought quotations for the first step in the process which includes –

1. Making a formal crown land enquiry to the Department Planning, Lands and Heritage (DPLH);
2. Drafting a plan showing the proposed road reserve and balance of Lot 566
3. Advertising and gazettal requirements, correspondence with other affected authorities; and
4. Compliance with any other DPLH conditions must be made before any outcome is determined.

If successful, the portion of land required is subject to valuation and as such, Council will need a budget to purchase the land from the State.

COUNCIL APPLIES FOR REGIONAL ECONOMIC DEVELOPMENT GRANT FOR NEW WORKFORCE ACCOMMODATION

The recent opening of a competitive grant round has provided an opportunity for Council to consider making an application for funding for the construction of new workforce accommodation. The proposed project and its financial implications are outlined within this item. The item requests that Council resolves to endorse the submission of the application.

There are two main housing challenges being experienced not only in the Shire of Carnarvon, but across the Gascoyne region. These challenges include quality and quantity, particularly as it relates to the provision of workforce accommodation for workers from various government agencies. In the past 10 years, only 20 homes have been built in Carnarvon, rendering the median age of the housing stock at 50 years. The housing stock quality has implications on values and desirability of housing. Initial consultation with several government agencies and private business owners, including Department of Communities (as managers of the GROH program) and Horizon Power has identified that the lack of housing is limiting employment growth, therein creating resource strain that negatively impacts service provision, which has a further impact on population growth and associated development within the Shire.

Regional Economic Development (RED) grants are an annual competitive funding opportunity offered by the State Government and delivered locally through Regional Development Commissions. In 2022, the RED grant round opened in July and will consider contributing up to \$100,000 for individual projects, although up to \$250,000 may be considered for applications that address the objectives and criteria to a very high.

The project proposal has achieved strong support from government agencies and private industry.

Council agreed to the funding application for a Regional Economic Development (RED) grant for funding of \$250,000 for the development of a two-dwelling development on Shire owned land in Parnaa View, Northwater Estate which includes with a maximum budget of \$1,250,000, consisting of the Shire's contribution of \$500,000 from Housing Reserves and borrowings of \$500,000 to leverage the \$250,000 of RED Grant funding.

New Intensive Family Support team in Carnarvon to enhance support for at-risk youth

Wednesday, 31 August 2022

- The McGowan Government is delivering a new Intensive Family Support team in Carnarvon to help keep children safe at home
- The additional resourcing builds on existing service provision in the region and will focus on intensive, early intervention with at-risk children and families
- The new team will form part of a \$36.7 million State Government commitment to deliver and enhance child protection services
- New Community Youth Officer role to support delivery of Target 120 program in Carnarvon

The McGowan Government is set to deliver a child protection staffing boost for Carnarvon with the establishment of a new Intensive Family Support team.

The new team, comprising of 5.5 FTE positions, will deliver intensive support to local families whose children are at imminent risk of coming into the child protection system, or families who are working towards reunification. It aims to help children remain safely at home with their parents by providing counselling and in-home supports. The additional resourcing will build on existing service provision in the region and focus on intensive, early intervention with at-risk children and families.

There will also be a new Community Youth Officer role in Carnarvon to support delivery of the new Target 120 program in the region.

Target 120 helps create safer and more connected communities by tackling factors that increase chances of offending, including substance abuse, lack of housing, domestic violence, trauma, mental health issues and poor attendance at school.

The investment forms part of the McGowan Government's \$36.7 million commitment to deliver and enhance child protection services, including an additional 36 new child protection workers to bolster capacity on the frontline. The funding, announced in the 2022-23 State Budget, was packaged as part of a \$75 million boost to expand child protection supports and increase investment in early intervention programs.

The State Government's record investment in early intervention in child protection initiatives is helping to support historic reductions in the number of children in care.

Comments attributed to Child Protection Minister Simone McGurk:

"Child protection workers perform a critical role in supporting vulnerable children and families.

"The addition of an Intensive Family Support team in Carnarvon will have a significant impact on the local community and will help keep children safe at home where they belong.

"I am proud of the work the State Government is doing to reduce the number of children in care. In the past two reporting years, we have seen the first reductions in children in care for 25 years.

"The McGowan Government is committed to addressing the overrepresentation of Aboriginal children in care and our focus on early intervention is helping make progress to close the gap."

In accordance with Section 6.33 and 6.35 of the Local Government Act 1995, the Shire of Carnarvon hereby gives notice of its intention to impose differential rates and differential minimum rates on all rateable unimproved-valued (UV) properties and gross rental valued (GRV) commercial/industrial properties within its boundaries during the 2022/2023 financial year. The differential rates are imposed based on predominant land use as detailed below (all categories are included for comparison): -

GRV Residential	11.7872 cents	\$1,228.00
GRV Special Use/Rural	11.7872 cents	\$1,228.00

SHIRE OF CARNARVON WORKFORCE SHOWS STRONG GENDER EQUITY

The Shire of Carnarvon will be implementing its first Reconciliation Action Plan over the next twelve months, after Council voted unanimously to formally endorse the plan on Tuesday.

The actions are grouped into 4 pillars under a theme of 'reflect' – relationships, respect, opportunities and governance – with goals and deliverables outlined for each. The plan was developed in partnership with Reconciliation Australia, Yinggarda Aboriginal Corporation, Nganhurra Thanardi Garrbu Aboriginal Corporation, and the local community. Prior to being presented to Council, the plan was submitted to Reconciliation Australia three times for feedback and received conditional endorsement on July 8.

Shire President Eddie Smith said Council is committed to reconciliation and forging strong connections with Traditional Owner groups and the local Aboriginal and Torres Strait Islander community.

"Council is taking an initial step on the journey to reconciliation by focusing on learning, promoting, and celebrating more about the world's oldest continuing cultures, and by building our cultural competency," said Cr Smith.

"We will continue to work with the Yinggarda people, as the traditional custodians of this land, and the wider community to make positive and meaning advancements through the actions and deliverables of this Reconciliation Action Plan," he added.

The lands on which the Shire is situated is an area of great social, cultural, and spiritual importance to the Yinggarda and Baiyungu people, along with Thalanji, Thudgari, Malgana and Wadjarri peoples. According to the 2016 Census, 960 people identified as Aboriginal or Torres Strait Islander which represents 21.7% of the total overall local population.

YOUNG SCIENTISTS IN THE MAKING

The Shire of Carnarvon kicked off National Science Week commencing 15 August with a Slime Making session at the Mayu-Mia Youth Hub today. These ten inspiring scientists were fascinated with the experiment and created some funky-looking slime.

National Science Week is an annual celebration of science and technology that runs each year. The Shire of Carnarvon is proud to run a series of activities across our facilities to inspire our bright young minds.

During the week the scientists go to participate in slime making, at the youth hub and monochrome artwork, stories and craft and lego maze design/balloon powered cars at the Library and Art Gallery.

As a co-located public library and art gallery, the Shire facility provides regular STEAM (Science, Technology, Engineering, Arts, and Mathematics) programs and activities to support youth development and learning. These programs are offered throughout the year at the Maker's Hub, LEGO Club, Minecraft and Book Clubs.

Building with LEGO can teach kids critical skills without them even realizing they are learning! It can spark creativity, develop problem solving skills, and explore basic STEAM concepts (plus it's also a heap of fun!)

NOTIFICATION OF WORKS - REMOVAL OF COCONUT PALMS - CARNARVON FASCINE

Earlier this year, a mature coconut palm along the Fascine fell to the ground as a result of strong and sustained winds. This occurred in the vicinity of the Carnarvon Hotel on Olivia Terrace. Fortunately no property damage or injury occurred as a result of this incident.

As a result, an inspection of approximately 180 palms and trees along the Fascine was conducted by the Shire.

That inspection identified five (5) coconut palms at risk of similar failure in high winds.

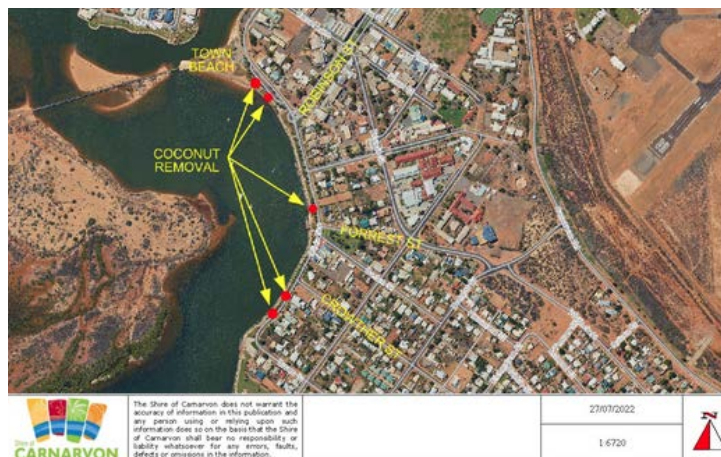
In the interest of public safety, these palms unfortunately need to be removed.

To ensure retention of the tropical character of the Fascine, mature replacement palms will be replanted at each site. They will be approximately 4m in height and will need to be secured by bracing until their root systems fully establish.

Shire contractors will be carrying out this work in the near future. Appropriate signage and barriers will be in place during these works.

The public is requested to keep clear of any palm removal works along the Fascine and to please keep clear of the new palms and their supporting wires.

TOWN BEACH IRRIGATION

Residents are advised that the Shire has experienced a significant wiring fault with its Town Beach irrigation system. Grassed areas in the vicinity of Town Beach normally irrigated with recycled water at night cannot currently be watered this way. Alternative manual irrigation may need to be utilised until the fault is rectified. Grass in these areas is likely to become brown however it will recover when normal irrigation is resumed. We are working to correct the fault and return the system to normal as soon as possible.

NINE MAJOR PROJECTS EXPECTED TO ADD SIGNIFICANT ECONOMIC GROWTH TO THE CARNARVON REGION

The Shire of Carnarvon has detailed 9 major projects, out of many others, planned for the Gascoyne region over the next 10 years in their latest economic report On The Horizon. With planned capital spending of over \$30 billion across several sectors – including energy, tourism, and horticulture – the projects will create an influx of job opportunities, drive tourism, and diversify the Shire's economic portfolio.

Projects planned for the energy sector are expected to bring over 8,000 construction and 3,000 operations jobs to the region. Plans include the Gnaraloo Green Energy initiative currently being investigated by Fortescue Future Industries which would develop a renewable energy generation hub with wind turbines, infill solar arrays, and nearby port facilities. The Green Hydrogen Project with Province Resources will supply renewable hydrogen to both export and domestic market.

Tourism initiatives outlined in the report include a \$40 million upgrade to the Ningaloo Reef Resort and an \$8.6 million accommodation village for resort workers in Coral Bay, and a phased development of accommodation units, caravan park, and camping ground at Babbage Island in Carnarvon with 332 accommodation sites total and resort-style facilities. All tourism projects are expected to create 450 construction jobs and a further 95 hospitality positions.

In addition to job creation and economic benefits, the 9 major projects are expected to attract new population to Carnarvon and surrounding areas. Current estimates have more than 800 workers and their families living within the Shire by 2029. There is expected to be further demand for infrastructure and social services to support the growth in population, including 55 additional childcare places, 6 schoolteachers, 350 dwellings, the addition of 26 flights between Perth and Carnarvon, 5 new hospital beds, 5 police officers, and one General Practitioner and one Nurse. The Shire will be calling on the State Government for support, including investments in housing, retail, and commercial developments.

WHAT DO I NEED A DEVELOPMENT APPROVAL FOR?

Development approval also known as Planning Approval is a legal document that allows for a use of a development on a particular piece of land. Development approval is required to ensure that any use or development of land within the Shire of Carnarvon complies with the Schemes, Residential Design Codes, Policies and other relevant legislation.

RESIDENTIAL DEVELOPMENT

- Construction of a single house, ancillary dwelling or outbuilding (or additions to these buildings) where a deemed-to-comply requirement of the Residential Design Codes is not met and a 'judgement of merit' is required). Note, a single house, ancillary accommodation or outbuilding that meets all relevant deemed-to-comply requirements of the R-Codes is exempt from development approval.
- Construction of or additions to grouped and multiple dwellings (e.g. units, townhouses, apartments,).
- Modification or demolition of a place that is listed on the State Register of Heritage Places, or Shire Heritage List, or where it is subject to an order under the Heritage of Western Australia Act 1990.

HOME BASED BUSINESS (HOME OCCUPATION)

Development approval is required for the use of a residential home for a home-based business could include, though not limited to:

- Food - such as jams, sauces, other condiments, cakes (no cream).
- Bed and breakfast - one meal (breakfast) per day.
- Family day care - food prepared in a residential kitchen for no more than six children
- Hairdressing
- Beauty therapy

Development approvals for home-based businesses may require approval from the Shire of Carnarvon's Environmental Health team.

SIGNAGE

All signage proposals within the Shire of Carnarvon require the submission of a development application.

Where applications comply with the requirements of this policy approval may be granted, subject to relevant conditions. New signage and advertising need to take into account existing signage and endeavour to remain in keeping with the character of the area.

Before applying for a Development Approval please see the checklist on Council's website for information required for both residential development and home based businesses.

BEACH RULES - DESIGNATED DOG EXERCISE AREAS

The designated dog exercise area runs from the car park on Pelican Point Road, just north of the public toilets, along the beach up to the One Mile Jetty. Dogs are not permitted on the beach at Pelican Point, south of this carpark.

Dogs may be exercised off leash as long as the owner has verbal control of their dog. If you can not control your dog or it does not come back to you when called, you must keep them on a lead to stop them harassing other beach users. An infringement of \$200 may be issued for a dog being uncontrolled in a public place.

Horses are permitted in this area each morning from 6am to 8am only. Outside of these times, a \$50 infringement may be issued.

Registered Road Vehicles are permitted on the beach and must not exceed 15km/hr. A \$50 infringement may be issued.

All **Off Road Vehicles** such as motorbikes, quads, all terrain vehicle, buggies etc, are NOT permitted at any time. Your vehicle may be seized and you may be issued with a \$250 infringement.

No Camping is permitted anywhere within the Shire of Carnarvon unless in an approved campground. A \$100 infringement may be issued to each person.

If you see someone in breach of these rules, you are encouraged to take photographs and report to the Carnarvon Rangers. Remember the beach is there for everyone to enjoy, so please respect each other.

How can I exercise my dog safely?

There are a number of areas throughout the Shire of Carnarvon where you can exercise your dog. This map shows the on and off leash areas, as well as the prohibited areas. Reserves within the Shire of Carnarvon are clearly sign posted.

Where can I exercise my dog?

The Shire of Carnarvon has designated many reserves called 'dog exercise areas'. In these areas your dog may run freely and below are a few helpful hints to help you avoid on-the-spot-fines:

- A person capable of controlling the dog must be near the dog at all times.
- Carry a leash so it can be quickly attached to gain control of the dog.
- Remove any excreta left by the dog.
- The dog must not chase or harass any other person, animal or bird.



Excreta

Permitting your dog to excrete on a street, reserve, someone else's yard or other public place and failing to remove and adequately dispose of such excreta is an offence under the Shire of Carnarvon Local Laws relating to Dogs.

REMEMBER the dog must always be under effective control, so if you can't control your dog then keep it on a leash.

Other than the areas listed as dog exercise areas or prohibited areas, dogs must be on a leash at all times in a public place.

This is a requirement by law of the *Dog Act 1976*.

CORAL BAY

Dogs are required to be on a lead in all public areas within Coral Bay & Maids Landing areas. No Dogs allowed on beaches (see DBCA for more information).

WHERE AM I NOT ALLOWED TO TAKE MY DOG?

You cannot take your dog to the following areas under the Dog Act 1976; unless it is an assistance animal under the Disabilities Act 2006:

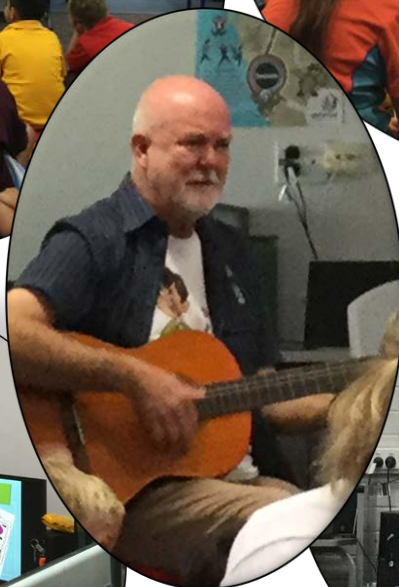

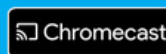
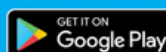

Social work students settling happily into Gnullingoo Mia placement

11 August, 2022

Social work students Maggie Leung and Ulani Ho from the University of Western Australia on rural placement with the WA Centre for Rural Health in Carnarvon tell us about their placement experience.

"The Carnarvon experience has been an adventure for us so far.

Being our first practical placement, it can be nerve-wracking to do a rural and remote placement. However, spending a week at the WA Centre for Rural Health in Geraldton was very helpful in preparing us for Carnarvon.

On commencing our placement at Gnullingoo Mia (GM) Residential Care in Carnarvon, the people we work with, staff, residents, and families have welcomed us, and we feel lucky to learn alongside them.

The thing we love the most about doing a placement in Carnarvon is how close the team is. We will be collaborating with other allied health students and the residents at GM. Having a multi-faceted team and community helps in catering for the needs of the residents.

We have come to Carnarvon at an ideal time and have had the privilege to experience NAIDOC Week. The rural placement has allowed us to integrate our learnings about Aboriginal ways of Knowing, Being and Doing into practice at GM and in the community. Incorporating culturally responsive ways of engagement is at the forefront of our work at GM.

Aged care is such a dynamic space where it is important to work alongside clients' families and other allied health professionals. We are learning about service provision for Aged Care in the regions and the different challenges that social workers encounter.

The uncertainties that Covid brings and the limitation of resources in the regions, has highlighted the need to look after yourself before you can take care of the others.

The advice we would give to other students is to 'Stay curious and ask questions!'. When you are a student, it is an ideal time for you to explore and be open to learning. Asking questions is so important when collaborating with others as well as engaging with clients."

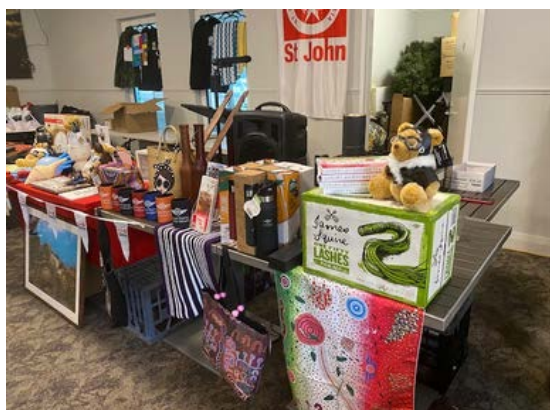
CORAL BAY AUCTION A RESOUNDING SUCCESS!

RESTRICTED BURNING SEASON IS OVER

The Shire of Carnarvon's restricted burning season came to an end on the 30th April 2022. As of the 1st May 2022, you no longer need a permit to burn, however you are still required to exercise caution, manage smoke nuisance and ensure there are no plastics, chemicals, rubber, tyres or other materials that create black smoke when being burnt. Burning these materials releases toxic chemicals into the environment and can result in a penalty of up to \$5,000.

If you are unsure of what you can burn, please give Rangers a call on 99410019 and they will be happy to give you some advice.



HAZARD REDUCTION - FIRE BRIGADE ASSISTANCE

With winter coming, this is the perfect opportunity for owners to do some hazard reduction work on their properties. This can be achieved by:

- Mowing, slashing and removing long dry grass or vegetation.
- Raking or utilizing machinery to remove leaf litter and dead vegetation.
- Controlled burning is an effective way to reduce available ground fuel, however controlled burning requires considerable experience in order to be carried out safely.



If you are not comfortable in conducting a burn yourself or would like to burn a larger area on your property, the local Volunteer Fire Brigades can assist with your burns for a fee, subject to volunteer availability. Please note that this service is available on land that you own or rent only, and does not include areas adjoining your property, including road verges. All funds raised through conducting burns on private property go directly towards supporting your local volunteer fire brigades.

Engaging the brigades does not remove the landowners responsibility to adhere to the Firebreak Notice. Contact your local brigade for more information:

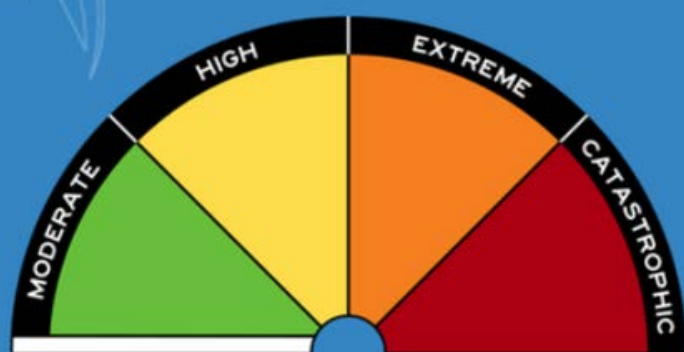

New Fire Danger Rating



Launching on
1 September 2022

From September 1st, the Fire Danger Rating System will be reduced to four levels -

- Moderate,
- High,
- Extreme, and
- Catastrophic.

You will see the new system in action across the country - this means that whether you are at home or on the road, you will be able to recognise the same rating system.

The new fire danger rating system is designed to deliver more precise and timely information by utilising the latest science and community input.

There will be actions for each level, so you know what to do to protect your life, family and property. For more information on the ratings and messages, please see below

Supporting messages, including localised information, will clearly explain what community response is required at each level.

The AFDRS also introduces an 'off' or 'no rating' level (white strip under Moderate) for days where no proactive action is required. This does not mean that fires cannot happen, but that they are not likely to move or act in a threatening way.

MODERATE

Name/Colour	Fire Behaviour Index Range	Suppression difficulty
MODERATE (Green)	12-23	Most bushfires in this category. Fires typically suppressed with direct, parallel or indirect attack.
HIGH (Yellow)	24-49	Initial attack success critical to prevent large fire development. Defensive suppression strategies.
EXTREME (Orange)	50-99	Defensive suppression strategies. High levels of threat to life/property. Safety of firefighters and community paramount.
CATASTROPHIC (Red)	100+	Unsafe for firefighters and community. Without initial attack success, likelihood of very large fire development is very high. High probability of loss of life and property.



PROTECT YOURSELF FROM MOSQUITOES

There is no cure or vaccine to protect against mosquito borne diseases acquired in Australia. The only way to prevent infection is to avoid being bitten. This can be done by -

- Covering up and wearing long, loose fitting, light coloured clothing, covering as much body as you can.
- When outdoors and mosquitoes are present, apply insect repellent containing DEET (diethyltoluamide) or picaridin evenly to exposed skin.
- Clean up - making simple changes around your home can reduce mosquito breeding. Remove, empty or cover water-holding containers.



HANDY HINTS TO PROTECT YOU FROM MOSQUITOES

Maintain fly screens to keep mosquitoes out of your home

- Maintain fly screens on windows, doors, vents and chimneys. (Screens should be no coarser than 12 x 12 meshes per 25mm, or 1.2mm. Use an even coarser mesh if you wish to keep out other smaller biting insects, like sandflies.)

Use insect sprays and repellents around the home

Insect sprays and repellents can be used both inside and outside the house to kill mosquitoes. It is important to use these products according to directions on the bottle.

- Use 'knockdown' fly spray against visible mosquitoes in your home.
- Use plug-in mosquito "zappers" or vaporisers in enclosed verandahs. These should be switched off as soon as the area is no longer in use. Consider using insect repellent at the same time.
- Use mosquito-coils in outdoor areas. These should be supervised at all times. Consider using insect repellent at the same time.
- Target areas like spraying the shaded shrubbery near your home. Avoid spraying these products near fish ponds. Remember to read instructions about safe use of any insect sprays.
- If mosquitoes are particularly bad, consider using a long-acting surface spray in areas where mosquitoes like to rest.

Limited mosquitoes from breeding in your yard and garden

You are first in line to be bitten by mosquitoes that breed in your own yard and garden! Mosquitoes can breed even in the tiniest amounts of water. Remove stagnant water so mosquitoes can't breed.

- Clean up your yard and remove anything where water can collect, such as unused pots and tyres.
- Cover or overturn trailers, wheelbarrows, boats, tools and children's playground toys to avoid water collection.
- Regularly clean gutters and drains so water runs freely.
- Mend leaking taps.
- Change pet drinking bowls, bird baths and vase waters at least once a week, and more regularly in very warm weather.
- Put sand around the base of pot plants.
- Keep swimming pools well maintained or empty or securely covered if not in use.
- Keep fish ponds tidy with minimal vegetation around the edges.
- Keep lawns and gardens trimmed back to reduce the areas where mosquitoes rest.

Check and maintain rainwater tanks and water storage vessels

- Water tanks must be completely sealed. Check lids, covers and inlet pipes for any gaps.
