**IMPORTANT INFORMATION**

**Public Liability**

Mobile traders and any other hawker, trader or stall holder who is regarded as medium or high risk must have—and provide a copy of—public liability insurance to cover them for at least \$20 million in the event of injury or loss suffered by a member of the public as a result of the licensed activity. If you are in this category, please include your certificate of currency with this application to avoid delays.

**Food Traders**

Food Business wanting to trade under a Hawkers/Traders/ Stall Holders Licence must be classified as exempt under the Food Act 2008 or hold a Food Business Registration Certificate. All food business are required to comply with the Food Act 2008 and the Australia and New Zealand Food Standards Code at all times.
